STRATEGIC DEVELOPMENT

- The FAQ "How do I ship back my rental textbooks to the Bookstore," has been added to our <u>FAQ page</u>.
- The Norco College Access to Technology Survey was closed April 20th. The Institutional Effectiveness team has posted the report on the IR website. Also, we're working on an infographic to summarize the data and shall include that in a May Regular Update. A few highlights:
- We had an impressive 903 student respondents (8.2% response rate; 903/10,953)
- o 99% of students indicated having access to the internet
- o 99% of students indicated having access to hardware/software they needed to be successful
- o In collaboration with Academic Affairs & Student Services, 131 students provided contact information requesting follow up and contact has been made for all. Our ad hoc Survey Response Team rocks!
- Students indicated a high level of effectiveness and reliability using text messages as a primary mode of communication (after Canvas and email). Purchasing group texting software is being discussed as a result.

- Student applications for COVID-19 CARE funds for RCCD students now available at RCCD.EDU/covid_funding_resources students should apply ASAP as funds are limited!
- Eligibility requirements are the following:
- o Must be enrolled in Spring 2020 at the time of application for aid

- Students were notified at 12:00pm on 4/27 and as of 2:17 p.m. there were 2,937 applications. We have roughly 40,000 unduplicated students in RCCD.
