The project is to help people understand and identify important intersections and locations. The project aims to produce unobtrusive landmarks.

Project itself:

Letters will be added to buildings to better locate and identify each building. There will be some signs that will illuminate at night which will make them easier to spot. Some lights will be photovoltaic, while others will need to be connected to underground cables.

The Norco College logo will be placed near the campus entrance.

3 directory boards will be spread across the palm pathway. It has a map to guide students to where they want to go.

Pylon signs at the entrance of the college will make it easy to define locations

Name plates and maps can be swapped to make it convenient and less costly to change, allowing

modularity.

Signboards will be placed to direct students to specific locations across campus.

Dr. Romero: This was approved by Student Trustee Melody prior to this meeting. She mentioned that there was money to spare, and she would like to see it used. She also mentioned wanting a suggestions box in the ASNC. She plans on having an open forum event where students can ask her questions.

Desiree's plan was to move the funds to the banquet as a temporary repository.

Jose: We clearly want to see the money used. Wouldn't it be better to use the funds to benefit the college as a whole?

Jose motions to amend the allocation of budget to Activities. Cheryl seconds.

John mentions there would be more value in moving the allocation of funds to ICC instead.

Emiliano motions to amend the amendment to instead move the allocation of funds to ICC. Rafael seconds.

ICC budget is currently at \$8,000. Each club has a budget of \$2000 maximum to spend, but most use around \$500

Josh: Since the senate has a vested interest in clubs, as almost every member is very active in a club of their own, this might not be the best use of fund allocation.

Jacob: Jose could set a policy to limit each club's banquet spending.

Josh mentions that there was one collective banquet last year which all clubs could attend.

Josh recommends a motion for the purchase of caps and gowns using the budget instead.
