Motion by Jim Thomas, second by Sharon Crasnow to approve the minutes for the December 7, 2011 meeting. Motion approved.

Motion by Dr. Dieckmeyer, second by Melissa Bader to amend the February 15, 2012 agenda to include discussion regarding target FTES for Norco that were received last night. This would normally go to the EMTF meeting, but that committee is now part of the ISPC. Request to insert the FTES discussion after Information Item "C" on the agenda. This would be an action item. Motion unanimously approved.

## I. <u>Information Items:</u>

## A. Survey of Planning Councils – Dr. Aycock

- Every year a survey will be conducted on the effectiveness of the planning councils. The surveys will be conducted during the Fall semester.
- Last Fall three different surveys were given, one to each council (APC, SSPC and BFPC)
- The ISPC reviewed the recent survey results for each area.
- Suggested improvements for next year's surveys.
  - o Add comment lines
  - o Create one survey for all councils
  - o Possible change in process to encourage more discussion
- Need to work on better response from constituents.

### **B.** College Updates – Dr. DiThomas

Dr. Gray is coming next week (February 23) to give a budget update. The update will
indicate the district's reduction amount and he will indicate the amount each college
will need to cut. Currently nothing has been settled for the individual college
reduction amounts. Norco will reduce their discretionary funds and then will have to
make hard budget cutting decisions.

- Art gallery many people indicated that this was outside of Norco's prioritizing circles, but an art instructor/gallery attendee is the number one faculty priority hire.
   Karin Skiba will be coming to the next ISPC meeting to talk about the Art Gallery. Salary savings from Karin Skiba's retirement will run the art gallery this year and next. No general funds will be used.
- Dr. Di Thomas is participating in an on-site accreditation review for another college. She indicated that Norco needs to be sure that all planning is tied to our budget allocation. The BFPC is where all the Vice-Presidents will go with proposals on how to reach the cuts that need to be made. Those suggestions will then go to the ISPC.
- Accreditation reminder that the Chairs/Co-chairs of the SPC Committees are responsible for the Accreditation Standards that are mapped to their committee.
- A steering committee will be created to work on accreditation self-review.

#### C. FTES – Dr. Dieckmeyer and Melissa Bader

- Reviewed handouts indicating the target FTES for 2012-2013.
- Target reduction is 269.22 FTES from last year or about 54 sections. Will also need to meet our budget target.
- In the past we did not reduce the number of sections in Fall, have already reduced Summer and Winter as much as possible. Suggestion to follow same process.
- Discussion on reduction of summer.

Motion by Dr. Dieckmeyer, second by Dr. Crasnow to follow these guidelines as a target FTES plan. Minimally touch Fall, minimally touch Winter and Summer and leave the remaining number of cuts for the Spring term. This will be adjusted as further information is considered. Motion rejected.

Motion by Dr. Crasnow, second by Melissa Bader to form an ad hoc committee to look at data and make a recommendation about the exact section cut numbers per term for the 2012-2013 FTES plan. Motion carried with one no.

• Ad hoc committee will be made up of – Rebecca Choy, Dr. Dieckmeyer, Dr. Green, Melissa Bader, Dr. Farrar, Dr. Aycock, Dr. Rey

## **D. Technology Plan** – Dr. DiThomas

 Norco's Strategic Plan and the Technology Plan both expire on June 30. A new committee is beginning to review the current Technology Plan. It will follow the same timeline as the Strategic Plan revision.

### **E.** Revision of Strategic Plan – Dr. Zwart

- SWOT analysis will be looked at regarding goals/revision of the Strategic Plan.
- ISPC will be looking at the Mission Statement at the next meeting.
- Dr. Green will be sending out sample Mission Statements to review prior to the next meeting.
- During the next meeting we will break into sub groups to address each objective.
- ISPC will review the strategic plan along with the goals and objectives that we currently have.
- It is very important that everything is tied to the Mission Statement.

- Working on evidence collection. Working on lists to make sure that everything is linked to our planning agenda items.
