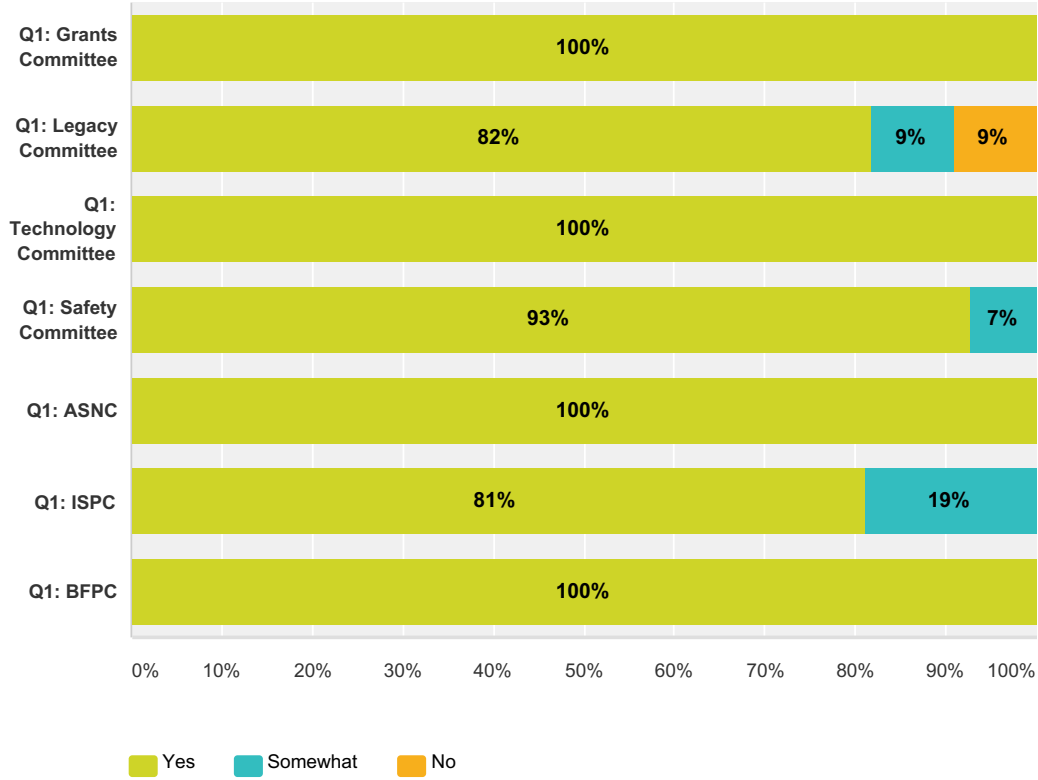

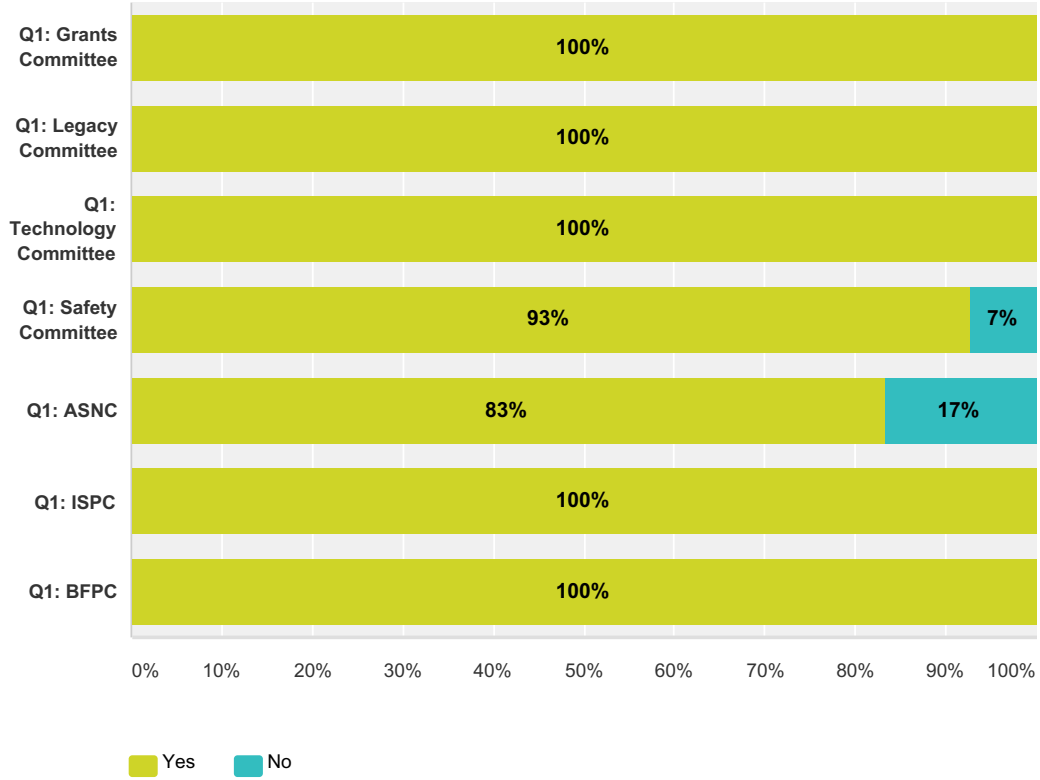

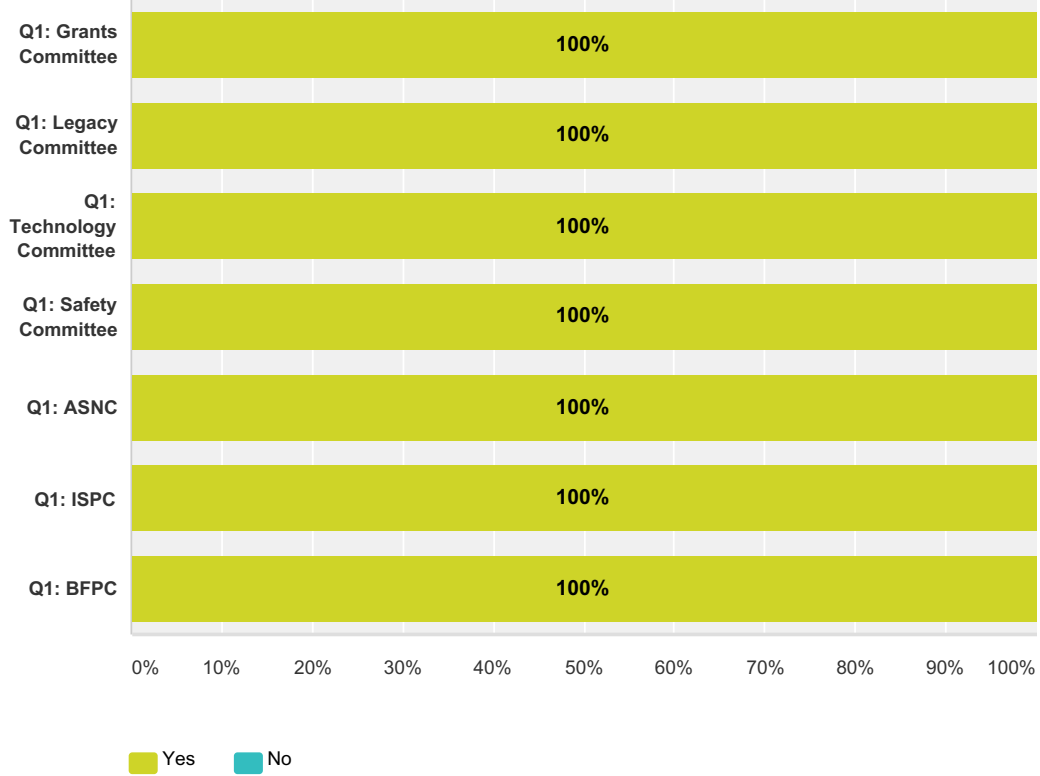

Q4 Are the agenda items usually completed within the meeting time?

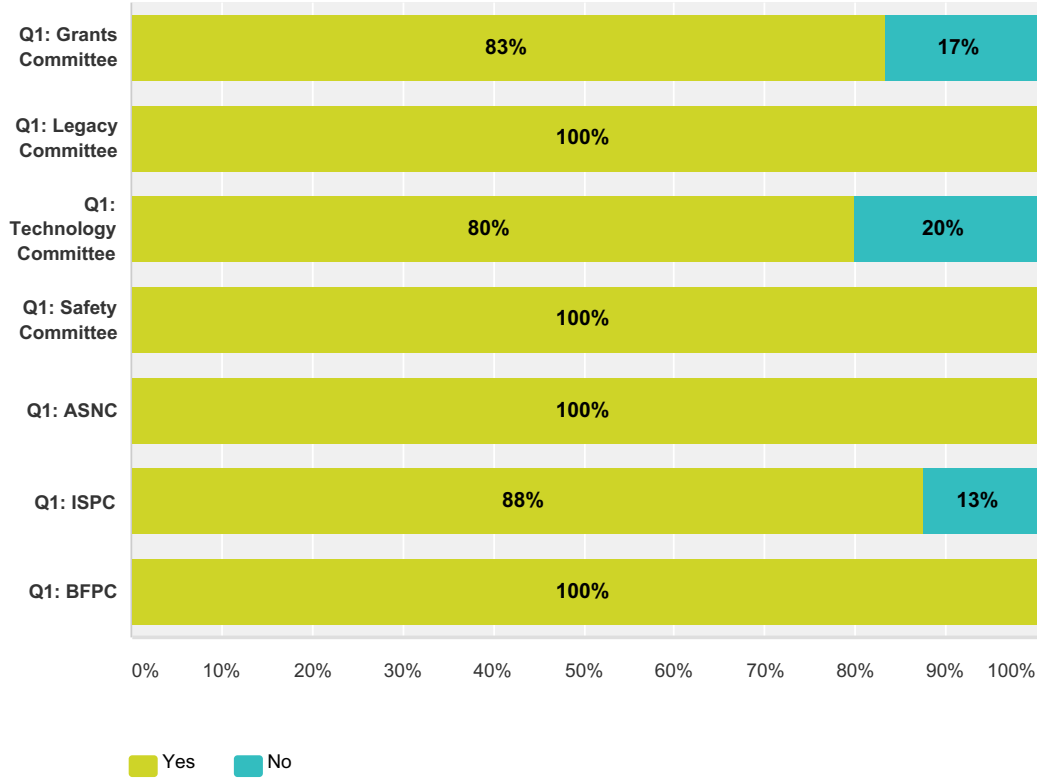

Q5 Are committee members given adequate information to make informed recommendations and decisions?

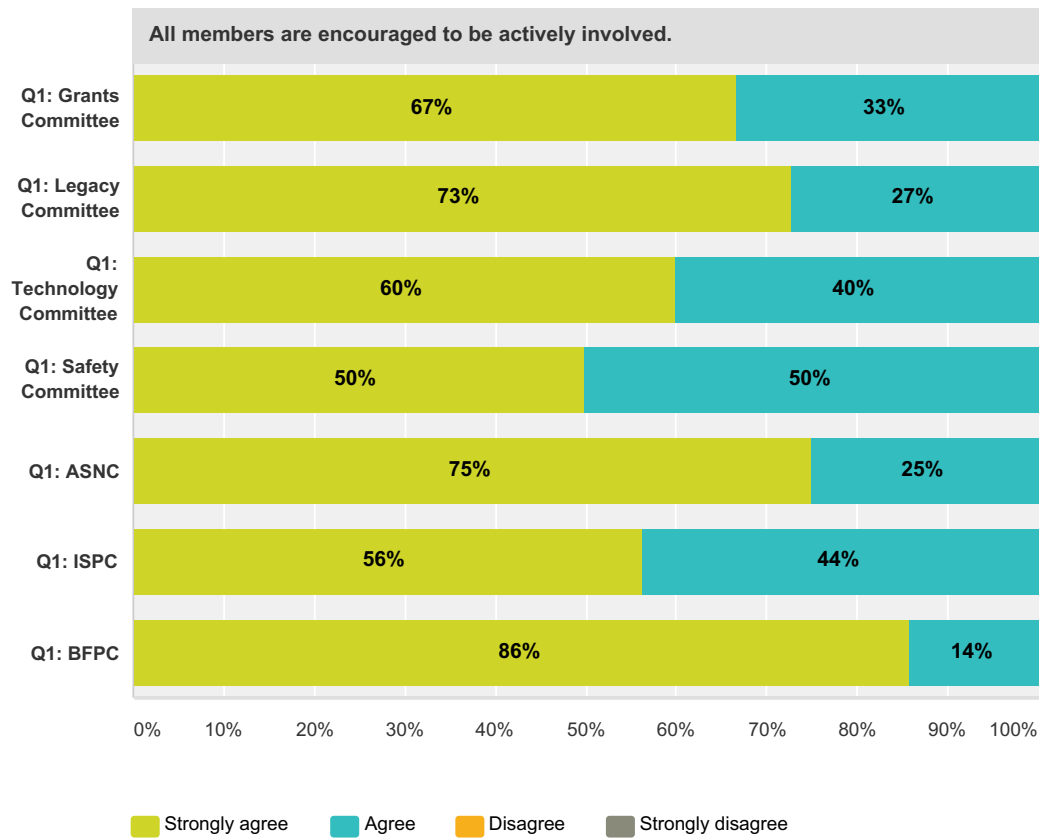

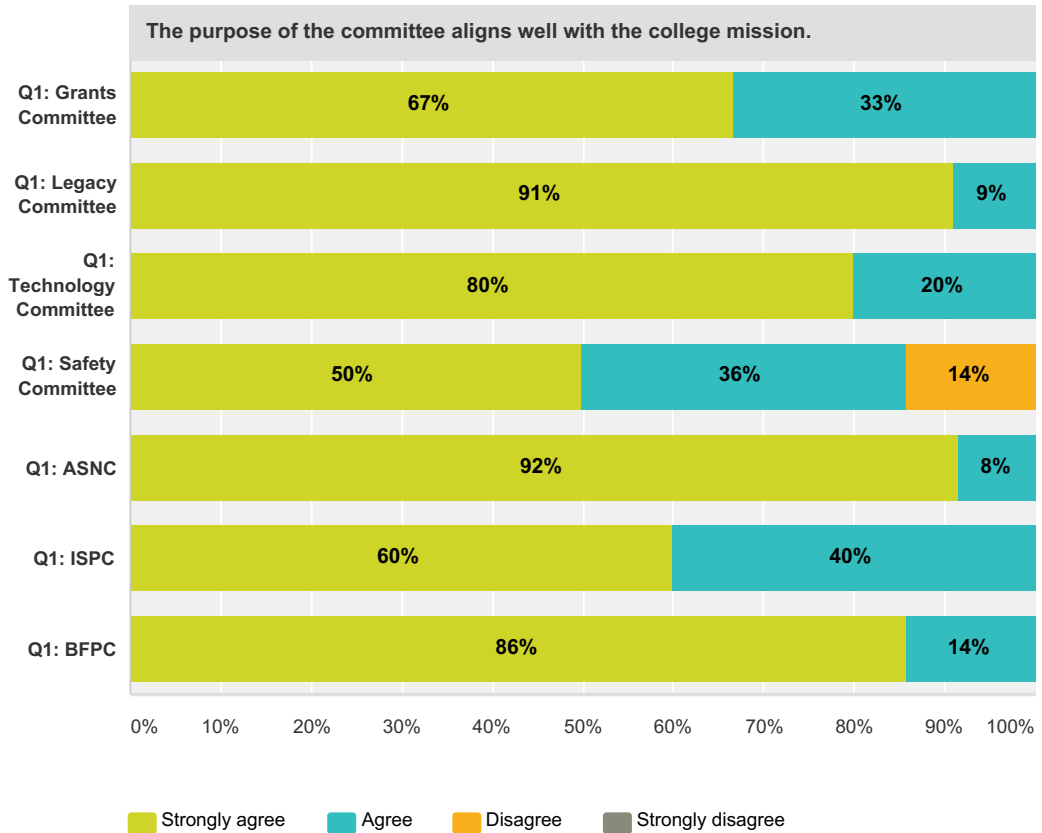

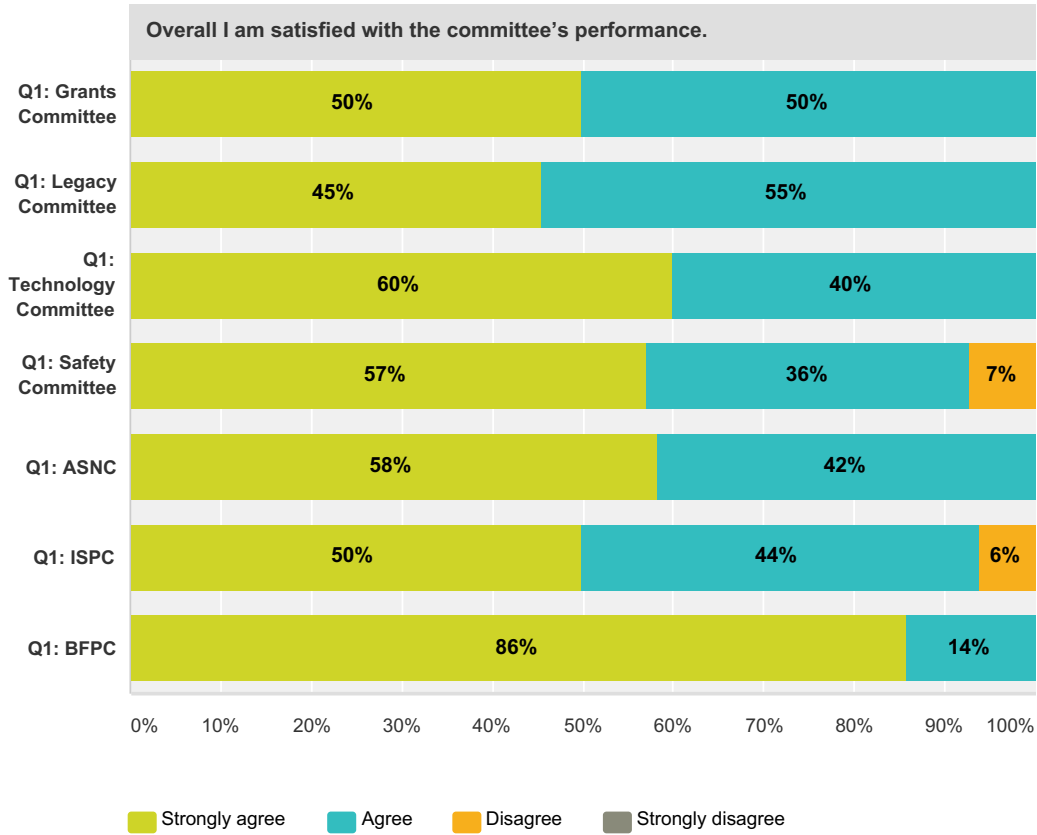
