2024 Objective 8.6: Build and support student services to foster student engagement, wellness, and success in the classroom and outside the classroom

• Norco College has received a \$2.7 million five-year federal <u>Title V grant for Project PACES</u>: <u>Pathways to Access</u>, <u>Completion</u>, <u>Equity</u>, <u>and Success</u> to implement Guided Pathways Student Success Teams and transition to more of a case-management approach to students in our four Schools. This award exemplifies a clear benefit of institutional reorganization and how the Strategic Development unit supports the College: With less than a month to complete and submit the grant application, the College was able to leverage indirect funds from previous grant awards to hire a consultant to help ensure this application was completed on time. Though there are no new indirect funds resulting from this Title V grant, it significantly bolsters our student support services for Guided Pathways. Dr. Tenisha James, dean of Student Services, will take the lead on implementation. EMP draft changes made in collaboration with Executive Cabinet can be summarized around four guiding principles: feedback from District Strategic Planning Council, ensuring alignment with the approved Facilities Master Plan, relocating non-measurable objectives, and demonstrating a clear alignment with the District Strategic Plan by matching metric reporting. Attached to the email are a summary of changes, information on using "track changes" in the document, and a copy of the September 27 draft of the EMP. - Accreditation 2020 News! Beginning late September, the institutional self-evaluation report
 (ISER) will proceed through college councils, the Academic Senate, and ASNC for readings and
 approvals. The ISERs for all three colleges in the district are scheduled to go to DSPC on October
 25 in preparation for presentation to the Board of Trustees Teaching and Learning Committee
 on November 5 and Board approval on November 19.

2030 Goal 1: (Access) Expand college access by doubling current headcount and FTES.

2024 Objective 1.3: Expand enrollment with strategic groups (Dual Enrollment, International, Online, California Rehabilitation Center, Veterans, etc.)

- A total of 711 high school students are enrolled in Dual Enrollment classes in fall 2019, for a total of 2,881 units. Total enrollment and number of units per high school are as follows:
 - Eleanor Roosevelt High School, 218 students / 998 units
 - Centennial High School, 93 students / 352 units
 - Corona High School, 43 students / 188 units
 - Santiago High School, 113 students / 438 units
 - o JFK, 112 students / 360 units
 - Hybrid School of Innovation, 13 students / 39 units
 - La Sierra High School, 12 students / 36 units
 - CAVA, 42 students / 135 units
 - Jurupa Valley High School, 65 students / 335 units

2024 Objective 2.3: Improve overall 4-year transfer rates from 11.2% to 25.9%

• In spring 2019, local business owner Chris Miller donated \$5,000 to Norco College to support the transfer application costs for students in need. Students can now apply for a \$100 scholarship to be used towards their fall 2020 transfer applications. The scholarship application deadline is November 1, 2019. Scholarship application forms are available at the Transfer Center. The

\$5,000 donation from Chris Miller was gifted to the Norco College Visionary Circle, held by the RCCD Foundation, following the 2019 Dinner with the President event. A resident of Corona for nearly 50 years, Chris Miller is the owner of Thomas Miller Mortuary in Corona. He also serves on the Norco College President's Advisory Board, Rotary Club, Corona Valley Chamber of Commerce, The Unforgettables Foundation, and is a Commissioner for the Corona Parks and Recreation.

2030 Goal 3: (Equity) Close all student equity gaps.

 At its October 1 meeting, the Board of Trustees reviewed <u>Resolution 08-19/20</u>, which would declare the third week of October, beginning October 14-18, as "Undocumented Student Action Week." The board will vote on the resolution at its next regular meeting on October 15.

2024 Objective 5.2: Help develop regional identity, collaboration, and organization

California, with its highly diverse population and size, faces the greatest barriers in the nation to

to encourage and support full participation by all Californians. Norco College is collaborating

Committee.

2024 Objective 7.1: Help raise college-going rate in region to levels comparable to San Diego, Los Angeles, and Orange county and expand high school partnerships

On September 27, the Riverside County of Education met with county high schools to set up an
eSports tournament tentatively scheduled for January, to be hosted by Norco College, with
some student competitions leading up to the event. eSports helps creates ways for students to
think of themselves in the future as Norco College students and to see possible careers in fields
such as engineering.
