### 2030 Goal 3: (Equity) Close all student equity gaps.

- The Men of Color Mentoring Program is recruiting new students during spring. Faculty who would like a brief five-minute presentation in class may contact Justin Mendez, student success coach. All Norco College students are eligible to join. In the fall semester, there were 70 participants in the program, the majority of which were first-year students, and 63 of 70 (90%) are returning this spring semester. The program helped 45 students finish fall 2019 with above 2.5 GPA, 35 students with above 3.0, and 7 students achieved a 4.0! 2024 Objective 5.4: Establish the Center for Workforce Innovation to create and expand apprenticeships and work-based learning opportunities

 The College is currently pursuing leveraging our existing Facilities Master Plan within the immediate/forthcoming projects to construct a Workforce Training Center on site at Norco College.

### 2030 Goal 6: (Community Partnerships) Pursue, develop, and sustain collaborative partnerships.

 A Districtwide team, including the chancellor, the presidents of Norco College and RCC, four Board of Trustee members, and other district personnel, traveled to Washington, D.C., to advocate for our legislative proposals. Prevalent themes were reauthorization of the Higher Education Act, addressing student housing and insecurity needs, and support for veterans.

  advance social and restorative justice by counteracting poverty, inequity and trauma with high
  quality programs that offer meaningful opportunities for individuals, families and communities."

Five Keys just opened an equipping and training (EAT) cultural center in Norco, and the College is looking for possible ways to collaborate.

### 2024 Objective 6.2: Contribute to regional economic and workforce development by creating and expanding relationships with business and civic organizations

• The College is in exciting discussions with the Corona Naval Warfare Center about the possibility of creating a "tech bridge" at or near Norco College. The "tech bridge" is a space where higher education, industry, the city, and the Navy can collaborate on bringing innovations out of the lab to the marketplace, where the innovations can benefit the local economy and workforce. There are currently six tech bridges across the country, all associated with the Navy and universities. This would become the seventh tech bridge in the nation if it would happen.

• On January 31, Norco
College held its first
commencement ceremony
for the Prison Education
Program at the California
Rehabilitation Center.
Twenty-eight students
successfully completed their
studies and earned degrees in
business administration,
psychology, and sociology. Six
of the students graduated
with distinction. Some
students will continue their

# 2024 Objective 9.6: Develop strategy and work collaboratively with the district to increase the proportion of full-time faculty toward the 75/25 ratio

• The College participated in the January 25 California Community Colleges Job Fair near LAX. Norco College took the lead in bringing District colleges together to share a suite at the Job Fair, where institutions recruit applicants for full-time and associate faculty positions. Participation at the Job Fair is a strategy to increase equity and diversity in the hiring pool. Representing Norco College were Susan Boling, human resources liaison; Dr. Samuel Lee, vice president of Academic Affairs; the deans of instruction; and faculty from various departments: Arts, Humanities, and World Languages; Business, Engineering, and Information Technology; English; and Math. Dr. Quinton Bemiller, Academic Senate president, also participated. RCCD was one of 32 California community college districts participating, and 872 job seekers attended the event.

### 2030 Goal 10: (Facilities) Build a comprehensive and inspiring campus integrated into the region that serves as a destination for education, commerce, life, and the arts.

 On February 4, the management team participated in an emergency preparedness tabletop exercise utilizing the incident command system (ICS). The exercise was based on simulation of a significant earthquake taking place and impacting the campus environment.

# 2024 Objective 10.1: Plan and advocate for the funding needed to meet facilities growth to achieve the vision for a more comprehensive college

The College has teamed with the District to identify state-funded capital outlay projects.

#### 2024 Objective 10.2: Develop and maintain Facilities Master Plan

 On February 11, the Business and Facilities Planning Council reviewed the final narrative for the Facilities Master Plan, including location options for secondary sites and potential student housing on off-site locations.

#### 2024 Objective 10.3: Build out funded projects

- Three new hydration stations have been added! They can be found (1) on the west side of the Student Services Building, (2) between the Science and Technology Building and Little Theater, and (3) on the first floor of the Library, outside the Learning Resource Center.
- Construction on the soccer field turf replacement began on February 18. Instructional classes that were scheduled to use the soccer field are being held at SilverLakes in Norco.

# 2024 Objective 10.6: Develop plans and strategies to capitalize on state facilities funding to maximize local project funding availability

• The College will engage end-users to begin light programming of the final project proposal for a new library and learning resource center.

#### 2024 Objective 10.9: Develop and start implementing sustainable campus

• The District has chosen a vendor, DLR, to undertake a districtwide survey/study regarding solar feasibility.

### 2030 Goal 11: (Operations) Implement professional, intuitive, and technology-enhanced systems.

2024 Objective 11.2: Develop intuitive and technology-enhanced customer relations management (CRM) systems for the entire student life cycle ("from recruitment to alumni")

• The District Office is leading an effort to replace our current enterprise resource planning (ERP) software, Ellucian Colleague, potentially with Campus Management. Currently Christopher Blackmore, associate vice chancellor of information technology and learning systems, is documenting our major business processes and functional areas that would be included in a future migration. Any feedback should be routed through your area dean/vice president.

# 2030 Goal 12: (Resources) Develop innovative and diversified resources to build and sustain a comprehensive college and achieve our visionary goals.

• Norco College's application for Title III and V Institutional Eligibility has been approved by the U.S. Department of Education. Norco College continues to be designated as a Hispanic-Serving Institution (HSI) and as a Minority Science and Engineering Improvement Program (MSEIP). These designations permit us to apply for various federal funds (including Title V and Title III-Part E grants) and makes us eligible for a waiver of the non-federal share matching requirements under the Federal Work Study Program (FWS) the Federal Supplemental Educational Opportunity Grant Program (FSEOG) and the TRIO Student Support Services Program, among others.

# 2024 Objective 12.1: Plan and advocate for the general fund budget augmentations needed to meet operational demands to achieve the vision for a more comprehensive college

Business Services has just completed an update to the Total Cost of Ownership (TCO) calculator
that the college community can use to financially plan for the costs of personnel, physical

#### 2024 Objective 12.3: Support General Obligation bond campaign and implementation

- March 3 is the date for the California state primary election as well as local elections, and everyone is encouraged to get out and vote!
- On the March 3 ballot is a \$715 million bond measure, Measure A, which would provide funds, through property taxes, to allow RCCD colleges to grow as well as provide upkeep for current facilities. ### 2030 Goal 1: (Access) Expand college access by increasing both headcount and full-time equivalent students (FTES).

#### 2024 Objective 1.1: Go from 7,366 to 8,759 total FTES

As of February 18, 3009.80 FTES are enrolled for spring 2020, which is 103.4 percent of our 2,912 FTES target. We will still need to extract non-residents from this, which historically hover just above one percent. For comparison, last year on this day of registration we were at 2,960.14 FTES enrolled, 103.4 percent of target for spring 2019.

2030 Goal 2: (Success) Implement Guided Pathways framework.

District colleges presented Guided Pathways Essential Practices: Scale of Adoption Self-Assessments at the Board of Trustees committee meeting on February 4.
