While the college reported no Correspondence Education, there were times during the pandemic when our Rising Scholars Program, located inside the California Rehabilitation Center (CRC) in Norco, had to use correspondence strategies to maintain instruction. These were for courses scheduled in person during times when the CRC went into lockdown during COVID-19 outbreaks and our faculty and staff were not allowed entry to the faculty. During these times, faculty created correspondence packets to keep students progressing during lockdown then resumed in-person education when lockdown ended.
