Strengths:	Program provides comprehensive tutoring across the curriculum. Training is course-based over a 16-week period. Critical thinking is emphasized along with general tutoring topics.
Concerns:	Annotated bibliography will need to be further developed and improved to meet requirements at Stage 3 re-certification.
Recommendations for Continued Growth:	For purposes of CRLA certification, it is helpful to the review process if no sections are left blank on the application and h as much documentation as possible should be uploaded in the appropriate spaces (e.g. a spreadsheet or log of actual tutoring sessions that include time in and time out for tutoring sessions and activity for each tutor you hope to certify and an <i>Annotated Bibliography</i> of all training martials even those developed in-house).
