2. Area "E" eliminate lifelong learning
3. Discussion about AB 132 *"Improving access, AB 132 establishes a dual admissions program that provides eligible first-time freshman applicants the opportunity for guaranteed admission to the UC or CSU campus of their choice following completion of an Associate Degree for Transfer or another transfer pathway at a CCC. It also requires school districts and other educational agencies to confirm that high school seniors who have not opted out complete FAFSA or California Dream Act applications for financial aid."*
