1. Call to Order

2. Action Items

2.1 Approval of March 24th Agenda (Dr. Mark Hartley/ Ms. Dana White)

2.2 Approval of February 24th Meeting Minutes (Dr. Greg Aycock/Dr. Kevin Fleming)

2.3 Approval of adding equity question to Charter Template (Ms. Dana White/ Ms. Leona Crawford)

- In the Charge section, the current Charter template reads, "Identify and describe the primary work to be accomplished within the context of the overall goals of the college including specific EMP goal/objective alignment or as part of a particular strategic initiative (e.g. access, equity, success). State the connections specifically to equity and/or Guided Pathways."
- The proposal brought forward was to ask, "What is your committee's/council's role in closing the College's racial equity gaps?"
- Members discussed being inclusive of all five student groups identified/prioritized in our Educational Master Plan (Goal 3) and not prescribing solely a focus on racial equity.
- Long term, it was mentioned that we also want to align a governance group's focus on equity in their Charter with forthcoming Equity Plan(s) as the focused student groups may change based on data. It was recommended that Instructions should be written more broadly in the revised Charter Template to instruct groups to document their alignment with the current Equity Plan.

- The intent is not for groups to go back and re-do any Charters that have already been completed/approved, but for governance entities completing charters in 2022-2023 and beyond.
- It was discussed to form a small workgroup to refine the Instruction language and to propose if the Guided Pathways language would be left in the "Charge" section or pulled out into their own separate heading/section also. Interested IEGC members are to email Kimberly Bell to join this workgroup.
- Approved by consensus to table approval of adding equity question to Charter Template. A workgroup will convene to make edits and bring to April's IEGC meeting for review.

3. Discussion Items

3.1 IEGC Workgroups

- Of the five workgroup opportunities presented, two were populated with volunteers for this spring (IEGC Ranking Rubric and SPGM Groups Definitions) and the others shall be subsequently convened in the fall term. These two workgroups are to bring their recommendations/proposals to IEGC in May 2022.
 - While we want/need IEGC members to be on our Council workgroups, other Mustangs (not members of the IEGC) may certainly join these short-term workgroups by contacting their constituency group leads; Kimberly Bell, faculty co-chair, Ruth Leal, classified co-chair, and Kevin Fleming, manager co-chair. Students and confidential employees may contact any IEGC co-chair to volunteer.
- The five workgroups are:
 - 1. IEGC Ranking Rubric
 - 2. SPGM Groups Definitions
 - 3. Document control process
 - 4. Assessment systems
 - 5. Prioritize IEGC deliverables and EMP objectives


