 - A. Overview of SSSP/SE/BSI <u>Integrated Plan</u> Goals and Activities Action Item-First Read (Oceguera, James)

Dean of Grants and Student Equity Initiatives, Dr. Oceguera and Interim Dean of Student Services Dr. James will introduce the latest version of the goals and activities that were developed for the Student Success and Support Program (SSSP), Student Equity (SE), and Basic Skills Initiative (BSI) Integrated Plan.

David Mills moves/Kim Kamerin 2nd

- -Changes were made to Goals 2 and 5 added language for Disproportionately Impacted (DI) students
- -Activities under Goal One g. through j. were added
- Under Goal 5, e. was added

Discussion: "Was training previously only for specific faculty?" "Will Goal 5 e. be starting in Spring?" Answer: The certificate was for a select group of faculty over last Summer - Dr. Nelson is in charge of that. We will take it under consideration to 'Nor All' so more faculty can be included in that training. It's expensive, and we want to get feedback from faculty that took the training before we expand.

- Dr. James begins 'walking us through plan'
 - -"Future plans" mean current and future plans because we are already into the 2 year cycle.
 - -Pages 3-9 relate to the previous plan (2015-16) and reports out on those goals
 - -There are (5) integrated goals for 2017-19 plan
- Dr. Oceguera presented a summary of the Executive Report.
 - -Discussion on number 8 about coordination with other colleges in the district. MMAP has been a district wide conversation.

-LGBTQ and Homeless students added to plan and must be addressed as groups per state requirements.

Discussion: I'm concerned that students being placed according to MMAP will need more support.

Answer: We have money to address those needs and can add activities to goals 3 and 4.

Jim – this is a first read, so let's keep our comments to a minimum: we have a big agenda.

The Dreamers' Club Advisors and President seek the senate's support in the creation of a Diversity
Center at Norco College that could include space for Dreamers and other respective organizations on
campus including, but not limited to: LGBTQ, Men of Color, Umoja, Puente and Foster Youth.

Raising money for scholarships for dreamers that are transferring.

Advocating for a "Diversity Center".

Discussion:

Could Equity or grant money pay for it? Answer: Possibly.

Clarification of what action we are voting on:

"Diversity Center" would contain Umoja, Puente, Dreamers etc.

We are voting on supporting the creating of an "umbrella" center that covers a large number of student constituencies.

Could the space that was previously used for the Veteran's center be used for this?

Could we have a portable if we don't get "first dibs" on the Veteran's space?

1.5 counselors, financial aid (for veterans), could we do the same type of thing?

This should move forward to BFPC for consideration
