V. CTA Report-A. Covarrubias, V. Lee

 - Met with Administration on ongoing funding for Rising Scholars and the conversation will continue
 - Regular meeting with three Senate presidents and the Chancellor regarding AB 928; looking at anything that came to CEOs for the Lifelong Learning and Self-Development GE Pattern; discussing the impact of AB 928 on the District and the facilities; a resolution was brought to the CEOs and it was supported unanimously
 - Met with the Chancellor, the Faculty Association, and the Senate presidents about how the 16 faculty positions allocated to the District would be distributed; distribution will be five faculty positions for Moreno Valley College, five faculty for Norco College, and six faculty for Riverside City College
 - Working on reporting out on the Emergency Conditions Report
 - Need to start talking about the distinguished faculty lecturer; look for emails from Dan Reade regarding nominations in the Spring 2023 Semester

- B. President (Monica Green)
 - Wanted to thank Pathways in Enrollment Management Planning Workgroup; an enrollment plan is underway and will be written in the Winter Intersession for approval in the Spring
 - Chancellor comes to the College every month and has been presenting data; the September meeting was focused on access, equity, and success data; some corrections will be made, and the corrected version will be sent out for further discussion; the Chancellor presented on FTES and Efficiency during the November meeting and that presentation will be sent out and discussed in the Spring
- C. Vice President of Academic Affairs (Jason Parks)
 - Finishing up English, Psychology, and Engineering faculty hires this semester
 - Chemistry and Anatomy and Physiology faculty hires scheduled for the Spring semester
 - Presentation on Fall 2022:
 - o Spring 2023 Enrollment Trends
 - 7,478 NC Home Students in Fall 2022, but 808 dropped all sections at NC
 - 6,670 NC Home Students currently enrolled in Fall 2022, but 3,903 are NOT enrolled in Winter 2023 nor Spring 2023 at NC
 - Please encourage students to enroll in classes; this is the first time the college is tracking this information, so it is difficult to determine trends in the data

DE (R. Hitch)

 Distance Education – District Academic Senate President approved language for requirements for certification to teach online; looking to send faculty to get POCR trained; faculty should contact Ryan Hitch if they are interested in training

CSEA (D. Koch)

• Holding annual celebration on December 16th and there will be a hot cocoa and cookies event; 2023 classified professional of the year nominations coming up and CSEA is requesting that the celebration be moved to the Spring; classified professionals nominate classified professionals; Mustang of the Month used to nominate employees across classifications

• The Legislative Analyst's Office has projected a budget deficit, but reserves are healthy enough to manage the shortfall; however, next year there will only be COLA and no additional raises; the final break down of faculty positions at the colleges was determined for the 16 allocated positions; BAM still has sticking points for unique programs, as the committee does not want to run them as they cost; looking to create a formula for unique programs based on other neighboring colleges and also looking at FTES/FTEF calculation
