Discussion: Representative of choir program, Daisy discussed her involvement in the music program and the opportunities for travel. Requesting $\$ 6000$ for the trip to increase the student attendance. Looking at $\$ 16,00-\$ 2,000 /$ person with $18-25$ students and 2 advisers planning attend
Javier asked for clarification on the total cost of the trip
Edwin stated that the choir budget is $\$ 12,000$ for travel. Currently at $-\$ 769$. Which would make the cost come out of choir's uniform budget.
Total student pay would be $\$ 60,000$ of everyone could go. The $\$ 2,000$ student fee covers airplane, hotel, food, performance deposit, bus, and on-site travel.
Denying the increase would result in less student being able to attend.
