The Associated students of Norco College will vote on adding the following Language to the ASNC bylaws under article XV Section 1:(d. Candidates may not run for the same position more than once).

Motion: Aimee
Second: MK

Shawn: I agree with Raiann to not have this until next election, because the candidates have already prepared. Aimee: Once you vote something, its in our constitution to keep it there and put it in action right away, instead of waiting on it.

Shawn: Can I amend this to start next election?
President: Yes.
Shawn: I amend this line item to begin for the next election.
President: Discussion?
