Sen.09.29.01 Norco College Strategic Planning Motion Author: Angelica Calderon (Discussion/Action Item)

The Associated Students of Norco College will discuss and vote on Norco College's strategic planning and governance manual.

Angelica Calderon: Reviewing Draft 1. Covers planning on how information goes throughout the school. Shows what passes and what does not. Circles show how it goes from one board to another. ASNC is not on, but they do come to us and inform us about most things. A lot of the draft covers the committees. ASNC is in the draft and it says that we represent the students. No recommendations but one. She recommends the number of students that sit in each committee and should be more open rather than just one student, so we have more than one voice. No other changes on our part. In the draft it states all the current members of the councils. Will be asking for clarification on what councils' students have votes on.

Edwin Romero: ASNC gets its authority through the board of trustees. ASNC has the responsibility to represent the students on all the shared governments. We are the voice of the students when it comes to any plans that the campus wants to alter. Not seen as a shared governments committee because we make our own decisions. Shared governments report to the administration and the administration has the final say. We only have two committees that do not have a representative for those meetings. We can reach out to the club organizations. Strategic planning is usually changed every 5 to 10 years. Throughout the year is has changed a lot. There was a change of president. We do not have enough funds to fund the request to build more facilities on campus. They are asking for recommendations from all three of these groups before resubmitting the strategic plan.

Isaac Nunez: Wants to share the shared governments with the club leaders so if they wanted to go and have an input then they can attend. We want to see if the students want to be more involved and more aware, not necessarily replace us in the shared governments in the meetings.

Anisha Salhotra: If we did share the information with the groups, they should reach out to us so that we can see if they are truly interested. If they are interested, they would be able to attend and report back to us.

The Associated Students of Norco College will discuss and vote contributing \$2,000 from the trust account towards Norco College's Giving Week.

Edwin Romero: Every year we do this event. Prior years we did a dinner with a president, but this year we cannot do that, so we are going to do donations. Donations are going to come out of the trust account. The trust account comes from Wells Fargo, and they donate \$500 a month to ASNC. Primarily funding comes from them. Currently this year we are not getting that much revenue because no vendors have been on campus. Money is things for the students that they cannot usually fund like scholarships. In the past there has been donations from the staff, faculty and administrators. Local cities have donated as well by attending the dinner. It is different when there is an event compared to a straight donation. Trust accounts are more flexible than ASNC funds. Right now, we have \$15,000 in the trust account. We have used it for any time of giveaways that we cannot use ASNC funds for. Applications get filled out and a selection committee decides who receives the money or scholarships.

Angelica Calderon: The money in the trust is for the students. Isaac Nunez: Wanting to adjust the line item to more money (\$3,000/\$4,000) to help benefit the students.

VII. ASNC Advisor Report

Propositions

Edwin Romero: Proposition 18 is about allowing 17-year-olds who will be 18 at the time of the next general elections to vote in the primary elections and special elections. This would demand constitutional changes. Proposition 19 has to do with inheritance and how a property is transferred from one person to another. It is one way for people that own property, to avoid taxation. This allows people to transfer the tax assessments. Opposition are the taxpayers. If taxpayers are against it, then that would mean that they would be paying more taxes. Nine years ago, they had the same proposition and it failed. Prior years it has been how Norco College has impacted their lives in a positive way. Relations needs to start working on the flyer and plug in the details once they are available.

Edwin Romero: We had an event this past weekend. It was \$5 off to students who presented their Norco College ID. It was upsetting that no one gave good feedback or giving their input. A lot of aspects should have been considered. 1. You had to walk into the restaurant. 2. The flyer was late. We need to promote earlier, and we need to be able to participate ourselves.
