Samia Irfan: Last meeting we had went over proposition 16. In exec we discussed that how it would bring back affirmative action and discrimination to help minorities, but it could also be used against minorities. We should not be for it or against it and let the people decide for themselves.

Gerado Chavez: Coming to you to approve the solutions for proposition 16. It would impact our community colleges system. It would also make resources more equitable.

Edwin Romero: A resolution is basically you are representing the voice and the students at Norco College. What happens with the resolution is that is goes to the Board of Trustees. ## VII. ASNC Advisor Report

Edwin Romero: Next week we should talk about scheduling the senate meeting in Spring (will be talking about that next meeting). We also need to get priority registration dates out. If we cannot do that, we will have training within each committee via Zoom. Giving week went very well. The president was very happy that ASNC gave \$5,000 towards the emergency fund for students. Going to get a quote about getting a license for all students. They are negotiating statewide for licensing for the software that is more affordable. Makenna Ashcraft: Attended the conference last year and it was good. Online would be tough. We need to promote this and get a flyer out by next week. Based on a first come, first serve basis. It is good, but it is just hard to commit to six-days online.

## Propositions 22 & 23

Edwin Romero: Proposition 22 is regarding at based drivers. Currently at based drivers are considered contractors and not employees. It allows them flexibility to where they do not have to show up to work. If you vote no, they are going to be considered employees.

Angelica Calderon: I believe they should stay as contractors rather than employees because they do it on their own time. They like the freedom of being able to work when they can.

Tharek Phounsavat: I think we should vote yes because it gives them freedom to do it when they

Makenna Ashcraft: Agree with Angelica, because Uber and Lyft drivers should stay as independent contractors because they love the freedom that they have.

Crystal Gitonga: We should support it because she does DoorDash herself and it gives her the opportunity to be flexible.

Isaac Núñez: They should have the option to choose whether they want to be a contractor or an employee.

Samia Irfan: Been doing InstaCart, they protested for benefits and they can receive benefits. They fought for the rights and they won. I believe it is best to not have a set schedule because they should be able to do it when they want or when they can.

Tharek Phounsavat: Right now, they are independent and by voting no would change them to be employees. Regarding the propositions, they are purposely worded confusingly, where a no can mean a yes and a yes can mean a no. Read about them before you vote.

Arielle Benas: I agree with keeping them independent contractors because a handful of people that do have regular jobs so being flexible would be best for them rather than having a set time you have to do it because they would be considered employees.

Edwin Romero: Proposition 23 goes with Dialysis Clinic Requirements. They would increase regulations, meaning they would increase the costs. Voting yes supports dialysis clinics that they would have on-site physicians while patients are being treated and report their data on dialysis-related infections. The proposition has been on the ballot before in 2018 and failed. Would hinder patients and put patients in danger.

Samia Irfan: Pros and cons of prop 23. It says that it says that they can increase the cost of healthcare. It can cause a physician shortage and cause more people to be in the ER. It costs the people more money and it will also cost the clinics more money, which may lead them to close.

It can really put peoples lives at risk.

Makenna Ashcraft: How did this proposition come about? My understanding is that people with dialysis could not receive proper treatment.

Gerlene Ariel: Honestly do not agree with this proposition. Dialysis is a simple procedure that can even be done at home.

Arielle Benas: During the meeting there were not enough members to vote so they had to hold off on voting until next meeting which is in November. They are still deciding on what wording and language to use in the objectives. Went over the LatinX event, which was held the day after the meeting, October 7<sup>th</sup>. Also covered how they want to collaborate with ASNC to get a panel going for the students. Showed a month to month calendar to see what they can celebrate in each month like Black History Month in February and March and LGBTQI in April and May. Anisha Solhatra: The panel would be different students from different committees, and how the rough times have been on them as far as the pandemic and COVID. Also, how their clubs or groups have helped them get through it.

#### Finance

Tharek Phounsavat: We paid for the Circle of Change conference, which was \$4,000. Something that was brought up by Rochelle was that starting a lacrosse team. Last year we had a meeting about separating ASNC from Athletics, but we must fund it. I am in favor of supporting more athletics. It can result in more enrollment. We should also get more equipment for the cross-country team. We are getting a speaker from Dan for events. ASNC now has a speaker. Still looking into new computers and laptops for the office.

Rochelle Duran: Coaches lacrosse at Eleanor Roosevelt and trying to get it approved. Edwin Romero: It would be best to contact Mark because he has no staff right now and he needs more support for athletics. They do want to do a club team so this would be a good start. It would be expensive. Also, a part of a women's cross-country team, we would like more equipment to work with. One pedal squeaks, if we have the funds, we can invest in a couple exercise bikes so we don't have to ask soccer to borrow it. Also, team gear would be cool, and some students don't have the funds to have a successful season such as proper running shoes.

Makenna Ashcraft: Previously talked to Mark about it and he did mention that it is expensive.
