The strategic plan is a document that describes the priorities and the goals of the college. The decisions that will affect the school. Brooklyn and Yusuf sit in these communities that provide information.

SPGM reflects input and key updates that have been implemented within the range of the fall semester regarding faculty and staff members. The SPGM has been updated and has been seen to be challenging because of the lack of clarity, hence the update. The improvements made by "Chat Gpt" to help answer questions from the questionnaire.

The four sections have been made to improve clarity. The first section is planning and context to provide the information. The second section is the strategic plan, which is focused on student access and student equality of the goals. The third section is the governance manual that provides the decision-making, when the accreditors came to the student body government, they got feedback to improve the governance manual. The fourth section is the procedures in which the government entities make and compile their regulations for the school.

The commentary is being utilized to improve and finalize the SPGM in May and April.
