### Senate 05.09.03 Approval of the 2025-2026 ASNC Operating Budget Motion Author: ASNC Finance Team (Action Item)

The Associated Students of Norco College will discuss and vote to approve the 2025-2026 operating budget.

Motion: Mohammad | Second: Danny

Haroun: Started the proposal for the budget last week. Following 2 weeks will be spent on approving the budget.

Ruben Aguilar: Flag football coach trying to bring flag football to the college. Explained the increment in interest for women's flag football. They were the first ones to launch flag football for women in the district. Irvine Valley College requested collaboration to start a full league around the sport. They have 14 girls now on the Norco team each from very diverse backgrounds. Having their first scrimmage on March 7th, they lacked the proper equipment. Then they had their first tournament where they only had 1 substitute due to the girls availability. They also had a media day for all the girls. They now have 4 committed athletes. They want to work together with their administration, they want to purchase jerseys and lights for the field, as well as coaching stipends. They ask ASNC for \$5,525 which involve stuff like medallions, banquet, flags, wilson's footballs, meals. Now they request to bump the

total up to \$9,000.

Motion: Dilraj | Second: Yusuf

Ruben: Needs the extra 3500 for meals and equipment.

Haroun: Cut \$20,000 from executive contingency and already gave it to clubs so they don't have to come to ASNC over and over again.

Mohamamd: Likes the idea but rather the money be taken from a different source.

Danny: Recommends to take the money from ICC Collaborations instead.

Haroun: That wouldn't be great because people were already scared of taking money from ICC due to the recent policies.

Danny: Suggests that take the money from Choir, Executive contingencies and ICC.

Dilraj: sybau

Cole: Asks Ruben about the fiesta bowl they didn't go to.

Ruben: Fiesta got cancelled due to low attendance but will happen next year and is a big event for women's football.

Danny motions to amend to take \$1000 from Choir, ICC Collaborations, Exec contingencies, and Harvest Festival account.

The Associated Students of Norco College will vote to ratify the constitution reflecting edits (Legislative code, Article IV).

Motion: Mohammad | Second: Cheryl

Haroun: Proposes new conditions for ASNC president running requirements. The bylaws state that you need to be a member of ASNC for 1 semester. He wants to change that to a running member can be a part of ASNC at any time instead of a whole month. Which would promote better engagement.

Mohammad: Asks for clarification on the time.

Haroun: It could be any time.

Ethan: So then anybody could just join for a week and run for president.

Tristan: You already get reviewed before joining ASNC so running for president should be open to all deserving students.

Mohammad: Agrees that people that have potential should be allowed to run but people still need to have some foundation before becoming president.

Ethan: Give them at least 2 months before running for president.

Haroun: Argues that the interview process is there for that reason.

Tristan: Understands that but people running unopposed outweighs that.

Haroun: Believes that all these bills are there for improving the elections code for next year.

Dilraj: Thinks that a certain amount of meetings attended should be viable for eligibility.

Mohammad: Agrees that they should attend more senate meetings.

Haroun: Coming to more senate meetings doesn't equate to anything as people just talk and mess around at times.
