The funding cut makes supporting all the students in this program difficult.

The choir meets 3 days a week and spends 130 hours practicing.

They ask that we see their hard work and dedication, and not cut their budget by \$2,000 so they can still be functional and support students.

Choir members played music at the AAPI event and farmers' markets.

Yusuf: If funding does become an issue moving forward, you can always come back to ASNC with probable cause.

They're enrollment has been up since last year, and they hope to get more students next year.
