II. New Business

- **How to run a report in TracDat – what people will need to know to help with their Annual Program Review**
 - **Sarah demonstrated step-by-step for the committee on how to run a Assessment Course: Four Column report.**
 - **The most used report will be the four column report.**
 - **Instructors will need this information for the APR.**
 - **Put in your report sub-title.**
 - **Select the course(s).**
 - **Select the SLO status.**
 - **Select the semesters fall 2014 and spring 2015.**
 - **It might take a few minutes to run depending on the courses you selected.**
 - **Please show your departments how to run this report.**
 - **Sarah handed out an older template which she will be modifying and sending out. Please let faculty know there is a template, but do not give them this one.**
 - **Ad Hoc reports are a little more difficult to run because there are a lot more choices.**
 - **Sarah will e-mail out instructions on how to run the 4-column report.**
 - **Working with the Annual Program Review Template.**
 - **It was discovered that the there was a glitch on the APR template.**
 - **The drop down menu is not working at the present time.**
 - **Sarah will work with Jefferson to see if the problem can be fixed.**
 - **This menu was intended to be a timesaver, but if you have a faculty member who would prefer to copy and paste please have them email Sarah.**
 - **Greg stated that TracDat is a tool that can be used to help fill out APR. In TracDat the information is summarized.**

Discussion:

The question was raised if TracDat will be helpful for the Comprehensive Review.

The answer was yes, the Assessment: Course Four Column report will be helpful, but will not address everything that is required for the report.

- **Update on completed assessment from fall 2015—what can you do in your department to help?**
 - **Only had 33% of assessment was completed in the fall. This was only SLO assessment. By the second Friday of the semester we should have been at 100%.**

- All faculty that were to be involved in fall assessment were sent an email with copies going to the corresponding dean, and to their department chair.
- Sarah has asked the department chairs to bring this up at their next meeting and see if a person from each department can be assigned as the lead.
- The report to ACCJC is due at the end of March reporting on the percentages of courses that have never been assessed.
- Right now we are at 77% completion rate for assessments on courses that are on the books but have not been assessed.
- If there are instructors who can get their plan into TracDat, we can legitimately report this to ACCJC.
- Please, if you were unable to assess let Sarah know.

III. For the next meeting

- Please be prepared to give department updates regarding on-going assessment.
- We are going to “norm” ourselves.

IV. Good of the Order

- Greg gave an update on data for program review. We have gone from 3 charts to more than 25, adding things such as; awards data, how many students enrolled declared a major, etc. so there is a lot more data we can look at now.
 - The question was asked, “What is efficiency”? Greg stated it is a way of determining productivity in a course.
 - Where can raw numbers be found? Raw numbers can be found on the Program Review website.
 - Greg would welcome feedback from the departments to find out if this information was helpful or not.
