F. Discussion / Information items:

1. Course Objectives in COR: The committee didn't like the suggestion of putting the outcomes and objectives in the same field. If we are going to have objectives, they wanted them separate. It was asked if this committee is OK with the fact that some disciplines will take longer to put objectives in and that there will be sections of their COR's be blank? The committee was not in agreement of that. The concern is that it could take that discipline a few years to do it and open the door to a possible ACCJC violation. We need a more definitive plan since there are major changes happening in Silva Thomas's office. The state academic senate can help us with a technical assistance visit. In terms of accreditation, we can show proof that we are trying to work to attending this issue and working towards the best way to address the issue. This is a more thoughtful, intentional approach. All three colleges should express interest in asking for expert expertise from the State Academic Senate (this is a free service) and seek guidance on how do we transition and how has other colleges done it successfully? Nick Franco asked to get samples of different formats to look at so we can see how the outlines might look like. A suggestion is to have mandatory fields that drop down. Several committee members expressed interest in receiving more training on COR's in CurrucUNet. To understand what they are doing and why they are doing it. Brian Johnson states that he will tell them not to rush it so we can see how the curriculum process will run in the next semester. As a college, Norco College can request a visit from the state academic senate. Meta, the new version Curriculum program will be going live before June 30th, 2016. That will be the best time to make a change to the structure in the COR's.

2. PSY/SOC 48: Mark Wolpoff from RCC to talk about the PSY/SOC-48 courses. We are the last college in the Inland Empire to start their behavioral statistics class. The four year universities are requiring the new students who are psychology majors to have completed this course. The math discipline had their meeting on May 6th and their concern is that this course wants to meet the Math 110 descriptor. The district wide math discipline voted to not approve this because the point is for this to get C-ID approval for a math class and that it would be an equivalent to our Math 12 class; therefore, it should have received the math discipline approval and gone through the tech review process. The content is math and the prerequisite is math. Andy Robles spoke about how he doesn't want the math department to give the impression they are opposed to the idea, but they are split on what this idea could lead to. They are concerned about the possibility of the procedural changes it can also lead to (a loop hole). The courses (Psychology and Sociology 48) looks like a cut and paste job in the creation of this course. The other concern is that they are under prepared for psych 50. Mr. Robles expressed concern regarding the lab component in the PSY/SOC-48 classes. Mr. Robles suggested that Mr. Wolpoff change the class to be a 4 unit class, rather than a 3 unit class in the COR, offer it as 54 lecture and 18 hour lab course and run it like a Geography class. Or 4 unit lecture that incorporates the lab as part of the component, or run it like an ENG-1A with a 71 hour lecture and 18 hour lab attached. The biggest concern the Math discipline has is that the PSY/SOC-48 class is trying to do more than the math discipline does in their Statistics class, with additional concerns regarding the breadth and depth of the course. Mr. Wolpoff would appreciate any additional feedback or questions, to please email him. AP4260, that was approved last year, will affect this as well.
