#### N. Discussion items:

1. GE/AOE inclusion proposals from Fall 2017: We were to gather all the proposals to include courses in general education in the fall and district curriculum was supposed to look at them in December 2017. This fell through because of the new catalog deadlines. Heather will be compiling all the proposals that we got from the fall 2017 and will put together a list to examine this semester. For example, there were suggestions that we wanted to include Gaming and Guidance courses that we wanted to include in general education. Please let Brian know of anything that should have been on the list. At the moment, we take the recommendation of discipline on what courses should be placed in the GE/AOE. Brian will ask what are the specific requirements.

- 2. BIO course modifications and associated programs: Can of all the numbering be automatically changed and the response is No, because we don't have the personnel at district to do it. So the BIO discipline will need to bring their programs through with the new numbers. For catalog edits, Nick Franco and Nicole Brown will be making the edits for our catalog. Dr. Friedrich Finnern moves and Nikki Capps seconds that we fix the new Bio edits in the catalog.
- 3. AB 705 Dr. Lee: A discussion information session about this new law will be offered tomorrow at 12:50 pm in CSS-217 and it was encouraged that everyone (staff & faculty) attend this. We need to add this language to the catalog and information pages. We also need to change the English and Math grids as well.
