After careful review of the course outline of record, faculty have agreed that the unit count should be changed to three units, which provide more efficient delivery of the student learning outcomes. This course is also being incorporated into the Business Administration.
  - ii. FIT 1 Fire Protection Organization (M) The content of the this course can effectively be delivered through a hybrid format and potentially expand access to the course for our students.
  - iii. ADJ 12 Introduction to Criminalistics (MR) To meet CI-D compliance. The course description needed updating to reflect current forensic science preferences and standards, as well as a discipline meeting discussing changing laboratory hours to 12 hours for consistency, relevance, and student experience.

1. Curriculum timeline/deadline: Nicole provided copies to the committee of the memo that was released the morning of 9/25/18 and Brian spoke about the time line in detail. Anything that doesn't make the deadline for the catalog will go into the addendum. The addendum includes new courses, new programs, course inclusions, and elective editions to existing programs and modifications to non-program applicable courses, stand-alone courses. You cannot include in the addendum if you have a program or course that is in the catalog and you are making a modification to it, then there is conflict as the student has catalog rights. It will not be included in the addendum and will wait until the next course catalog cycle. All proposals board approved from January through June 2018 will be placed into the addendum as long as they make the required and are also state approved. CSU/IGETC decisions will be delayed. Discussion about providing a notation to the old document that will in the catalog and to place the updated document as a link on the website where the electronic version of the catalog is housed.
