- IV. ZTC Definitions and Course Mapping
 - Definition provided by MVC CMAC Chair, Angela Thomas:
 - ZTC definition
 - We changed the amount of resources the library would have to carry to consider it a class set. Our old definition said we had to have a copy for each student. We realized that not every student needed access at the same time, especially with electronic resources.
 - LTC definition
 - We added book rentals under \$50. We realize that the CVC-OEI will require LTC to be under \$30 but we can change this when we are closer to joining this. At this point, we have no idea how long this will take to figure out. We want to encourage LTC as a viable option to reduce the cost of materials now
 - AM and TF agreed that we should not make changes at this time and stick with our definitions as ratified.
