II. UPDATE PATHMAKER XB12 DATA REPORTING - (ADAM MARTIN)

Faculty need a more efficient method for reporting ZTC data for MIS submission to the state.
 The current process is cumbersome and inefficient. Adam Martin is working with administration and technical support to create a reporting step in PathMaker that will streamline the process.
 This reporting is mandated by the state under XB-12, and at present the entire district is out of compliance. Our goal is to ensure full compliance moving forward.

III. CMAC WEBSITE REVIEW AND UPDATE - (ANGELA THOMAS)

- We are committed to ensuring that the website remains as accurate and up to date as possible.
 Angela Thomas has updated the approved agendas and minutes, as well as the membership list.
 The list was reviewed, and a few adjustments were made, which Angela Thomas will incorporate into the next round of website updates.

 Cool4Ed is the platform where the state plans to share resources developed through ZTC funding. While this is a positive step, there is still a need for a more robust repository, one that can accommodate larger files and a wider variety of resource types beyond PDFs and Canvas course shells.

Bookshelves are currently organized by subject, which makes it challenging to create a
dedicated bookshelf for LibreText. Angela Thomas will investigate this further. Since we are
paying members, we were informed that this option should be available.

VI. PRESENTATION REPORT ASCCC GAMIFICATION – (ADAM MARTIN)

On April 24, 2025, Norco CMAC hosted a statewide conversation on Zoom, Leveling Up
 Education: Using OER to Gamify Learning. Adam Martin, James Finley, and Angela Thomas led
 this conversation and included one of the developers. The event was well attended and
 provided an opportunity to showcase works-in-progress, including several developing game based projects, as well as concepts for future initiatives. Our goal was to share these ideas early
 to spark interest and collaboration, particularly from others who may wish to invest in OER
 resources of this kind.
