- 1. Approval of the Agenda

- 2. Approval of the Minutes from 04/17/19
  - a. S. Burnett moves
  - b. S. Popiden seconds
  - c. All favor, 0 oppose, 1 abstain (A. Kramer)
- 3. Second Reading of AP 4105
  - a. Certification and Duration of approval are both topics of discussion since DE Addendums are approved and not revisited for most courses in the Curriculum
  - Canvas LMS should be used by all faculty as a best practice to ensure faculty receive training, to provide Section 508 compliance, to align with best practices in RCCD and OEI
  - c. Canvas LMS should be same for face-to-face and online students regarding Course quality standards and Section 508 compliance
  - d. District wide use of LMS requires more centralization of policies and procedures since Norco does not have administrative responsibility for Canvas LMS
  - e. Cooperation is key to our success with all 3 colleges in the District
- 4. Second Reading of <u>Summary of Regulations for Regular and Substantive Contact for</u>
  Distance Education
  - a. Student to student contact is a new initiative in addition to Title 5 §55204 Instructor Contact
  - b. ADA Section 508 compliance must be addressed as well
  - c. Training is key for faculty in design, assessment and accessibility

- d. Currently District requires opt-in for Canvas LMS to ensure training for all faculty using the LMS
- e. Spreadsheet of trained faculty tracks progress for College wide training
- 5. Second Reading of <u>RCCD Guide to Recommended Best Practices to Achieve Regular and</u>
  Substantive Contact in Distance Education
  - a. Supports AP 4105 with examples for faculty to better communicate with students
  - b. Committee needs to review over summer before voting in Fall 2019
- 6. Decision on DE Course Approval Process
  - a. District and Colleges Curriculum Committees and DECs need to work this out
  - b. DE Committee should examine proposals early in the process
  - c. DE member should sit in at Tech Review once the DEC has approved initial proposal

  - a. M. Bobo presented Spring Report to Senate at the May 16, 2019 meeting
  - b. Membership and goals updated to reflect priority of AY 2019-2020 Accreditation
  - c. Fall FLEX events will help educate faculty in lieu of the March 2020 visiting team to support training in
- 8. District News (Dr. Sheila Pisa)
  - a. Proposed Timeline to aid in Accreditation visits for AY 2019-2020
  - b. Pilot Program in Fall 2019 from RCCD will see how this tool works for students and faculty
  - c. RCCD Best Practices for Course Design will be finalized and disseminated to train faculty and promote buy-in
    - i. Based upon OEI rubric with RCCD branding
    - ii. Question of Accessibility (Section D) in OEI Rubric
    - iii. Current draft includes Sections A-C from OEI Rubric
  - d. Geoffrey Dyer, Cheryl Aschenbach and Conan McKay wrote <u>"Title 5 and Distance Education: Is Separate Course Review Enough?"</u> for the ASCCC which apprises DE faculty Title 5 §55200-55210 revisions including:
    - i. §55200 focus on ADA Section 508 compliance
    - ii. §55202 classes in DE is the preferred term not courses
    - iii. §55204 increased expectations for instructor-student and student-student contact. As in a face-to-face experience, faculty need to be present and communicative more than a boiler plate course approach with standard text and duplicated responses
    - iv. §55206 DE Addendums must have details regarding means to make up loss of face-to-face contact, ADA Section 508 compliance, how to achieve course outcomes, DE Committee approval and oversight
- 9. Feedback on Smarter Measure (Amy Kramer)
  - a. A. Kramer examined Smarter Measure in the Quest for Success to consider how it may impact onboarding of new students

- b. Courses should be opened earlier than the first week to allow students time to become familiar with Quest for Success and complete the assessments
- c. Counseling is concerned about the timing of implementation of Smarter Measure in light of EduNav launch
- d. Smarter Measure might be better implemented as a prerequisite to enrollment in online courses
- e. This raises an issue with District curriculum CORs would need to be changed
- f. We need District implementation of Smarter Measure to make this an effective tool for all students since online students come from all three colleges

#### 10. Good of the Order

- a. R. Alameida raised valid point of student training in Canvas. Instructional videos on how to use Canvas and how to participate in online courses would be greatly appreciated
- b. Introduction module is key to student success in the first week of each online course in addition to assessment tools like Smarter Measure
- c. DE Addendum must be revisited in Fall 2019 for District wide approval
  - i. Approval of Addendums is once for all
  - ii. DE Addendums not revisited so boiler plate language is crucial
  - iii. Emails should be revisited in light of ACCJC visiting team reviewing Canvas classes with Instructor access to the single class
  - iv. Emails are not archived by District
  - v. Canvas inbox messages are not visible to visiting team
- d. Curriculum and Distance Education need to work together with Senate in Fall 2019 to expedite Board approvals of policies
- e. Fall faculty meetings and trainings will be scheduled
- f. Each DEC member needs to promote best practices and disseminate information to departments and disciplines during the Fall 2019 campaign
