- 1. Self-Paced Versions of Senate Approved Online Teaching Certification Courses Motion to establish qualifications for a faculty review team, and identify faculty to review edits made to the self-paced draft of the Online Teaching & Design and Equity Courses and modify if necessary. (2:05 2:14)

If we are going to Consortium membership, why would we consider design rubrics other than the CVC OEI? I think our messaging needs to be really clear to the Senate that this is the path we want to take, versus creating confusion with alternative approaches. Unless qualified I would vote no here

 - I haven't had a chance to review the Peralta rubric so don't feel confident voting on it I would also want input from NC DEC prior to voting on this also does the CVC OEI rubric not cover enough content to be used for this? I'm wary of identifying too many elements for compliance in the OL environment that faculty aren't held to in the FTF classes, especially if we don't have a means by which to review Canvas courses when supporting a WE section only. I think this might need some input also from our Racial Justice taskforce and TLC committee, and the CTA I would vote no here for now until I understand the rubric more
