### **Approval of Minutes:**

Approval of Minutes for October 1, 2014

Motion by Deborah Tompsett-Makin, second by Lyn Greene to approve the minutes from the October 1, 2014 meeting. Request to include the time a member leaves during a meeting and the reason they are leaving early. Correct Lyn Green to indicate that she left for a personal appointment. Motion approved with two abstentions.

### I. Information Items:

### A. Institution Set Standards Methodology (Greg Aycock)

• Asking for feedback/comments on whether or not the college Institutional Set Standards should be revised or remain the same.

- For the purpose of this presentation "retention" is the same as persistence.
- Discussion on use of percent or number for comparison of degree completion, transfer and certificate completion.
- Discussed the need to determine what process will be followed should the college indicate it is getting close to the institutional set standard.
- Request that Greg calculate ½ a standard deviation below the mean to compare with the 1 standard deviation below the mean indicated in the PowerPoint and provide that information at the next meeting.
- Discussion regarding the need to have some type of flag or "bell" that will indicate we are getting close to the ISS.
- ACCJC says that we need to have ISS and we have to have a plan for what will happen if the college reaches our ISS.
- The Academic Senate will discuss what "plan" should be in place. The Senate will bring their recommendation to the ISPC.
- Discussion that whatever the institutional set standard is it may be best for the college to wait until it reaches that set standard twice before the issue is addressed. That way the college is sure that action is needed. It is possible that the standard could have been reached once and it was only a one time "blip". It does not necessarily mean that action should be taken.
- The consensus seems to be that we need to change our methodology because the ISS are too low.
- Question on using different methodologies for each of the items (course completion, student retention, etc.).

### B. Summer Advantage (Melissa Bader)

- Summer Advantage is about CNUSD Norco College and first time students.
- Just completed the third year of the program. Participation went from 50 students to almost 500.
- This is a yearlong program. Outreach is currently going on. There is a link on our website to the application and general information.
- Shared improvement statistics and money saving numbers. (see attached)

### C. District Strategic Planning Committee Update (Ruth Leal)

- Meeting held last Friday. There was a lengthy agenda.
- Agenda included a presentation on the Student Success and Support Program (SSSP).
- The Enrollment Management Committee should be meeting soon, working on a date.

### II. Good of the Order:

- Comments from Dr. Parnell:
  - Approximately 12 people from Norco College and CNUSD attended the Strengthening Student Success Conference. They did a presentation on the Summer Advantage Program. Norco was the largest group that attended.

- Equity Retreat was held on September 26. Worked on addressing student equity. Shows how so many groups are working for the good of Norco College.
- Announced that Norco College has received a partnership in a 1.4 million trade grant to train Automated System Technicians. Will be able to hire staff to work with the local manufacturing community.
- o There will be a manufacturing open house this Friday.
- o DSPC is currently in a developmental stage. We need to make sure that what happens in ISPC is communicated to the DSPC.
- o Art exhibit to open this Sunday night on Poetry and Art.
- Announced that our Soccer teams have been doing a great job on the field and in the classroom. All the students have a 3.2 grade point average.
- Read to Succeed book discussion on What it is Like to Go to War will be held on October 30. Next semester's book is The Distance between Us about immigration.
- o Chancellor Burke will be on campus tomorrow.

# Why are we doing this?

- Pg. 27 on Visiting Team Report, "The team recommends that the College evaluate the methodology to establish the institutional set standards to determine if one standard deviation below the mean is too low and does not sufficiently challenge the College to improve upon its current levels of achievement."
  - Ensure that all constituencies have input in establishing an institutional standard
- The ISS is not merely a number—needs to make sense if it is to be used as an institutional standard.

What if we calculated our ISS differently?
