- 3.1 Discussion Item: Senate Resolution
 - Cameron provides some context for the Senate Resolution: He drew inspiration from Norco College's core commitments, the State Chancellor's Office and the Human Rights Campaign 2018 LGBTQ+ Youth Report.
 - o Requests assistance with wording on the Senate Resolution
 - Peggy and Cameron began working on this at the end of Spring 2020.

- Should we spend more time on this or send it to the Academic Senate in November?
- Feedback on Senate Resolution:
 - We discussed adjusting the language and correcting typos.
 - We've been talking about the Senate Resolution for a while.
 What would be the advantage of putting this off until Spring?
 - Funding Question: The Chancellor has set aside 10 million dollars. This funding seems to be different from the funds that Norco College already has. The Governor's State Budget is allocating \$10m one time funds specifically to LGBTQ+ Student Support Centers in this year's budget.
 - One of our EMP goals is to close the equity gap amongst LGBTQ(IA)+ students. Goal 3, Objective 3.4
 - Cameron will correct the resolution and send the updated version via email.
- Marie moves that we bring this Senate Resolution to Senate this Monday, November 15th.

- 3.2 Discussion Item: Senate Charter (due March 2022)
 - Senate is asking LGBTQ+ Advocates create a charter for our committee to align with the EMP
 - Subcommittee goals will be added to our charter.

 - Due in mid-March 2022
 - Cameron will send out an email soliciting contributions to this Senate Charter.
- 3.3 Information Item: Unity Zone volunteers
 - Unity Zone Meeting Hours: Chris will have 20 hours a week (his position goes to the board this week). We also have a student employee, Alice, who will have additional hours.
 - Student workers need to have supervision during usual business hours.
 - o Faculty can volunteer to access the Unity Zone to open the space.
 - Daniela will assess the availability of the center given Chris' updated hours and Alice's hours. Once this is done, she'll send this to Cameron.
