1. Comprehensive College Plan Process: Dr. Lee discussed that the Chancellor has asked us to define what is a 'Comprehensive College' and to propose a plan. We drafted a plan and we pulled from Program Review and planning all long-standing strategic needs for institutional resource requests. Dr. Lee is open to receive an ideas to help move this forward to finalize the draft. The draft was received well from the Chancellor on our direction and aligned it with districts plan to access to success and equity.

EMP & FMP (TCO- total cost of ownership) Need to think about program review place in this process.

Adding to Program Review on the programs that are not yet created but forecasting future programs.

- 2. Revised Form for Resource Requests: Dr. Gray went over the fields online and the updates to the resource requests. Annual update 3030 is revised and the TCO was removed. Dr. Gray was concerned it wasn't updated or people were fixated on the items and not what is needed for the year. Dr. Gray will be updating the form. Dr. Aycock commented that he would eventually like to see what data affects assessment. Dr. Gray and Dr. Lee said that Nuventive is being reworked to reflect a better outline.
- **3.** Nuventive Improve Update and Requests: Dr. Gray has been attending more meetings with Nuventive to improve our forms and reports. Student services will be joining the call on March 23rd.

4. Listing Program Reviews on one Website: Dr. Lee would like to merge them into all in one and will be working on the links with Lenny Riley.
