I. Student Services Area Overview

1. Mission Statement

Norco College Upward Bound provides students with academic guidance, personal development and fundamental support to participants in their preparation for college entrance. The program provides opportunities for participants to succeed in their precollege performance and ultimately in their higher education pursuits. (Revised Fall 2015)

2. Philosophy Statement

Upward Bound provides services designed to increase students' knowledge and academic performance in order to meet postsecondary eligibility. The goal of Upward Bound is to increase the rate at which participants enroll in and graduate from postsecondary intuitions. (Revised Fall 2015)

3. Summary

- Guide students with the college application process, financial aid, and enrollment into a postsecondary institution.
- Provide opportunities for participants to visit four-year universities, cultural, and career related fieldtrips.
- Provide opportunities for participants to do career exploration and life planning.
- Offer activities to prepare students with the transition from high school into postsecondary institutions. Including a 2 year and 4 year UB Bridge track.

4. Strengths

- 83 percent of UB participants served during the project year had a grade point average of 2.5 or higher.
- 100 percent of UB participants served during the academic year 2016-2017 continued in school for the next academic year 2017-2018, at the next grade level, or graduated from secondary school with a regular secondary school diploma.
- 92 percent of UB senior participants that graduated in spring 2018 enrolled into an institution of postsecondary education by fall 2018.

5. Students Served

The Upward Bound Program-Centennial High School served 80 students from Centennial High School during the year 2017-2018. Our students met at least one of the three criteria:

- 1. Low-Income (per established federal guidelines)
- 2. First Generation, potential college students (self-reported)

- 3. Demonstrated Academic Need (per their school transcript grades)
- 4. 2/3 of participants are both low-income and first generation potential college students.

Report on 2015-2016 Assessment Plan and Objectives for Student Services Area: Upward Bound Program-Centennial H.S.

- In Centennial H.S. 55% of students continue to the next academic year. Our goal is to improve the high school retention rate of program participants from one academic year to the next by at least 15%.
- In Centennial H.S. 27.5% of students achieve proficiency level on state assessments. Thus our goal is to improve program participants' academic performance in standardized tests by 12.5%.
- 64% of our current students earned a passing score of 85% or better on the UB College Knowledge Pre-Test. Thus we aim to improve program participants' knowledge of postsecondary education academic requirements.

This SLO is important to Upward Bound because that is the primary purpose of our program. To ensure that students are prepare for college. Through the summer program 2016 and the academic year 2016-2017 we conducted many workshops to ensure that students understand the importance of having college knowledge.
SAO : Senior participants will achieve admission into an institution of postsecondary education immediately after high school graduation.	We modified this SAO and added the word enroll. We noticed that participants were getting accepted into an institution of higher education, but were not necessary being retain beyond the fall semester. To assist with this findings we are now doing more intensive follow up with our seniors that have graduated from high school to ensure they are retained in college.
SLO: UB participants will demonstrate knowledge and understanding of the financial aid process.	This year we continued to provide financial aid workshops to participants and parents. The last summer program we added 12 lessons and a fieldtrip to the Los Angeles Financial park, in which they simulated what it means to be an adult and be responsible for your own expenses. We will continue to provide these lessons during the summer program 2018.

II.2.B. 2018-2019 Assessment Plan Findings/Data Analysis

SLO/SAO #1: 83% of UB senior participants successfully completed their A-G coursework.

Findings/Data Analysis: SAO was met. A total of 20 out of 24 students (83%) successfully completed their A-G coursework requirements by the time they graduated high school.

Improvement Recommendations

- 1. Continue to introduce A-G requirements and college information in 9th grade and repeat in 10th grade.
- 2. Continue to make college entrance requirements workshops mandatory for all participants and to provide pre/post quizzes after each workshop.
- 3. Continue to provide senior seminars during senior year.

SLO/SAO #2: 92% of UB seniors who graduated from high school in 2018 enrolled in an institution of postsecondary education by Fall 2018.

Findings/Data Analysis: SAO was met. A total of 22 out of 24 (92%) of the seniors that graduated in 2018 enrolled into an institution of postsecondary education in the fall of 2018.

Improvement Recommendations

- 1. Continue to provide advising sessions on a weekly basis to seniors between August and November of each year to assist them with the college application process. We will continue providing advising during the summer program in order to get ahead.
- 2. We will provide a set time frame for Senior lab hours. During this time, seniors will receive one on one help with anything related to the college admissions process.
- 3. We will continue to assist seniors with the college enrollment process such as: housing, financial aid, submission of official transcripts.
- 4. Assist seniors in identifying postsecondary academic support programs for incoming first-generation and low income students. Ensure they apply for these programs.


SLO/SAO #3: 69% (9/13) UB junior participants demonstrated knowledge and understanding of the financial aid process on the UB Financial Aid post-test.

Findings/Data Analysis: *SLO was not met.* A total of 9 out of 13 (69%) of UB junior participants demonstrated knowledge and understanding of the financial aid process on the UB Financial Aid post-test.

Improvement Recommendations

- 1. Provide multiple lessons on financial aid during consecutive Saturday Academies.
- 2. Ensure the lessons are interactive and engaging.
- 3. Administer the pre-test prior to the first lesson.
- 4. Administer the post-test after the last lesson.

1.Blumen Online for TRiO (BOT) Database Reason: As a federally funded program, Upward Bound is required to collect and maintain substantial amounts of data on a yearly basis. An annual performance report is due to the Department Of Education once a year and we are required to complete 70 fields for each current and prior-year participant. BOT provides the adequate support needed to generate this detailed report. The BOT database increased from \$375 to \$1,590 yearly because we had to switch to the online version. There were multiple occasions when data was lost with the desktop version, this version was being managed by Information Services. As a program that depends on data for funding we needed to find a secure alternative to manage our student records. The program is now paying four times more to securely manage our data.
