## Program Comparison

---

### **How does your program compare to the college in the following areas: age, gender, ethnicity, FT/PT enrollment status?**

The number of students who have participated in STUDENT GOVERNMENT went from 17 in the Spring of 2019 to 14 in the Spring of 2020. This represents a decrease for this program. In age and gender during the Spring of 2020, there was a slight increase in the number of females involved in Student Government (64.29%) compared to the general population (52.65%). Also, in age, there was a greater percentage of students 19 and younger who participated in Student Government (78.57%) compared to the NC general population (34.50%) in Spring 2020. FT/PT and Ethnicity are in alignment with the college as a whole.

### **Program Comparison: Are there any gaps in demographic areas that need to be addressed?**

There are no negative gaps in the demographics. We are always looking for ways to engage a broader demographic of student through outreach and collaborations with clubs and organizations on campus.

## Program Student Outcomes Comparison

---

### **How do student outcomes for your program compare to the college overall in Student Educational Planning, Success, GPA, and Persistence?**

The percentage of students in Student Government who have met with a counselor and developed an educational plan is 47.06% during the Spring 2019 term and 50% during the Spring 2020 term. This rate is significantly higher than the general population of students at Norco College which is 13.71% and 11%, respectively.

In looking at all enrollments during the Spring 2019 term 63 students achieved a 79.4% success rate. This rate is higher than the general population of students at Norco College which is 71.3%. When comparing GPA between the college and the program, Norco College students had a 2.78 GPA and students in Student Government had a 3.10 GPA, which is moderately higher in GPA as compared to Norco College students. No data was available to compare persistence rates for this cohort of students.

Student Government evaluates the quality of services in two ways: 1) did the leaders in Student Government gain a better understanding of the purpose of shared governance, the Brown Act, and Roberts' Rules of Order than they had prior to joining and 2) were their constituents satisfied with the quality and quantity of opportunities available to them as a result of the leaders using the resources given to them via Student Service Fees.

**2. In what ways does this student service area support student learning?**

Student Government supports student learning through the philosophy of Learning by Doing. Through field trips, programs, leadership workshops and conferences, and shared governance opportunities. Students are given the chance to implement the knowledge they learn in the classroom and apply it to a real life situation where they have help, support, and constructive criticism if they stumble while attempting to learn a new concept.

**3. What strategic goals does this student support service area align with to support the college mission?**

2025 Objective 2.4: Increase number of transfers 15% annually.

**4. How has assessment data been used to improve this student support program or service?**

Student Life uses this data to adjust trainings and workshops on a year to year basis. We also utilize exit interviews to gain a better understanding of what incoming Student Government leaders would need to succeed in their positions.

**5. How does this student support service area assure equitable access to appropriate, comprehensive, and reliable services?**

Annually, the Associated Students host elections for positions ranging from president to senators to at-large members. The Office of Student Life intentionally seeks out students from a variety of backgrounds to compete for these positions. The diversity of the student body should be reflected in the membership of Student Government. ## EMP GOAL 5. Reduce working poverty and the skills gap.

---

### **GOALS AND ACTIVITIES**

#### **What are you doing now in support of this goal?**

The Student Life Office, along with the Associated Students of Norco College (ASNC), Basic Needs and Wellness,, and Student Activities has worked diligently over the past several years to establish a Food Pantry on campus emergency housing for our most vulnerable students. This was started during the 2016-2017 academic year. Initially, the Food Pantry was established with private gifts and donations; however, in 2018 - 19, the state created a Hunger-Free Campus Grant which helped to stock the shelves of the Food Pantry, as well as pay student assistants to work the pantry. The student assistants were typically homeless students or students who have struggled with food insecurities. It became a win/win situation for all involved. After the Food Pantry was successfully up and running, we turned our attention to students with housing insecurities. During the 2019-20 academic year, Student Life sought out ways to house students. Several meetings with hotels managers were arranged. The WoodSprings Suites were the most accommodating of those we met with. A discounted rate of \$77 per night (the typical rate is \$147 per night). A partnership was created, which made it easy for a student who found him/herself homeless to get checked in with no payment out-of-pocket for the student. A PO was established, and on the recommendation of the dean of Student Life, the General Manager of of hotel would authorize the check-in of the student. To date, 19 student have been removed from a very bad living situation and provided housing on behalf of Norco College. Students have been able to stay anywhere from three days to several months depending on their circumstances. This has been an ideal transitional situation for students until they find a more permanent living situation.

#### **What are your plans/goals (3-year) regarding this goal?**

Over the next three years, Student Life looks to continue this housing program while expanding the education of its existence to more faculty, staff and administrators. As more professionals on campus know about our program, we will need to increase the fund used to house student. In addition, as our numbers increase we hope to get even larger discounts from our hotel partner.

"Low-income college students are struggling to balance success in the classroom with meeting basic needs—including stable access to adequate amounts of food. While temporary measures have made CalFresh food assistance—known nationally as the Supplemental Nutrition Assistance Program (SNAP)—easier for students to access during the COVID-19 crisis, federal guidelines create enrollment hurdles for students and complexity for the state and its higher education system. In addition to demonstrating their income eligibility, college students must typically also receive certain kinds of financial aid or participate in specific types of employment [to qualify for](#) the program. California's community colleges, which serve large shares of low-income students, are working to reduce some of these hurdles through basic needs centers" (<https://www.ppic.org/blog/basic-needs-centers-at-california-colleges-can-help-fight-student-hunger/>). NC was one of the leaders in the state of California when implementing a food pantry. The need is larger than ever, but the staffing levels have not kept pace. This department needs to be more than just a one-person show. Our Basic Needs students need our help, but so does our Supervisor who is working literally 24/7 to keep our students feed and housed.

Two EMP Goals 3 and 5 (equity and reducing poverty) are met by fulfilling this staffing request. Our most vulnerable students deserve our support.

Even though the CCCs enroll a higher proportion of low-income students than UCs and CSUs, funding for and implementation of these centers on community college campuses have lagged" (<https://www.ppic.org/blog/basic-needs-centers-at-california-colleges-can-help-fight-student-hunger/>).
