# 3.2 Program Review Cycle- Draft Annual Updates Checklist

Reviewed MVC's annual update checklist to evaluate its suitability for Norco College's annual updates, particularly if the cycle is extended to five years.

The goal is to use a checklist as a guide for reviewing what needs to be addressed and updated each annual update year.

Concerns with using a checklist:

- People often leave the checklist until the last day of the annual update, which prevents them from completing all items in time.
- It may be necessary to customize the checklist for various disciplines and areas, but it is suggested to keep it general.

### Suggestions:

- It is important to explain the intent of the checklist.
- Conduct further research on other campuses' practices for annual updates and use of checklists.

The committee found value in using a check list framework to help make the process and idea of an annual update less onerous.

Co-chairs will draft a general checklist tailored to our needs over the summer for the committee to review in the fall.
