Topic 5: AED Update – Main Speakers: Justin Czerniak

All 5 AEDs have been found - 2 are located in police cars; 1 is located in CSS; 1 is located in the WEQ; 1 is located in Health Services.

4 of the 5 batteries are expired and Justin will work on getting new ones. Moore Medical is an approved vendor and we can purchase the batteries from them quickly and easily. We need to push for a safety committee fund. Currently, Justin has 50K allotted to him in a budget line for safety related purchases and the VP of Student Services normally gifts us \$3,500 for safety related items annually.

ADA access from the CACT Building going to CSS is flawed. There is only a ramp at the bottom of the turnaround forcing wheelchair students to go into the street and around to get to CSS. There are talks of adding more ramps. ASKIP used to have a mini grant for safety funds. We should look into the grant arena. Ask Gustavo for help. APA works with us, maybe we are able to use their grants?

Topic 7: First Aid Kits - Main Speakers: Alex Ward, Cintas

These pre-purchased cabinets are OSHA compliant. The company replenishes the items we choose and keeps the paper trail for us. They can come weekly, monthly, and/or quarterly depending on our needs. They do not charge for their services only for the items replaced in the cabinets. These cabinets a do not keep us liability if misused because we are not prescribing anything. Consenting adults are going in at their free will to take items they need in the event that first aid is needed. We are going to customize the cabinets per space. For example, in public areas there will no medications in the cabinets because those are given in Health Services. Also, because we have underage students on our campus who are not consenting adults, they cannot have access to medicines without written permission from a parent or guardian. An approved physician's letter will come with every cabinet. Cabinet A is for office type settings. Cabinet B is for maintenance type settings. Both are still completely customizable. All are barcoded for inspection purposes. They will put a barcode in on AEDs as well for free. Cintas also does trainings. The cost of each cabinet is between \$170 and \$190. This is dependent on the numbers of shelves in each of the units.
