## Japan plans mass vaccination as Olympic doubts mount

- Tokyo 2020's opening ceremony is in six months, but a surge in COVID-19 infections in Japan and worldwide has cast fresh doubt over the event.
- Japan aims to start vaccinating the general public against the coronavirus in May, just two months before the delayed Olympics are due to start, as more doubts emerge over whether the event will even take place this year.

## Doubling Up Masks Creates 'Obstacle Course' For COVID, Colorado Doctor Encourages You To Consider It

- Health experts saying wearing a mask provides protection against COVID-19 both for the person wearing the mask and those around them. Now we're hearing wearing two masks may offer even more protection.
- "Specifically what we're saying is that two masks may actually equal the protection you would get from N-95 masks, which is considered the best mask there is short of a complete respirator-type unit," Hnida said.
- "If we have people and give them an outlet for entertainment in the restaurant space, in the bar space, we have much more of an opportunity, in my view, to be able to regulate and control that environment," <u>Lightfoot said</u>. "People are engaging in risky behavior that is not only putting themselves at risk, but putting their families, their co-workers and other ones at risk. Let's bring it out of the shadows."

- Late last week, Chicago mayor Lori Lightfoot typically cautious on COVID-19 policy raised some eyebrows after calling for restaurants and bars to reopen "as soon as possible."
- Her logic: The current COVID-19 surge has been primarily fueled by at-home gatherings and parties, and if people are going to gather regardless of what any stay-at-home order dictates, state and local governments should try to provide spaces where at least some mitigation efforts will be taken.





## United States COVID-19 Cases and Deaths by State











## ICU Bed Availability by County




