

# NORCO ACADEMIC SENATE REPORT

## Fall 2018

### COMMITTEE STATEMENT OF PURPOSE

#### Norco Academic Senate Mission:

The Academic Senate operates pursuant to Title 5, Subchapter 2, Sections 53200 – 53206, California Education Code B. The Academic Senate shall concern itself with making recommendations to the College President and the District Chancellor and the District Academic Senate, and the College Vice President for Academic Affairs with respect to policy development and the implementation of matters in the following areas:

1. curriculum, including establishing prerequisites and placing courses within disciplines
2. degree and certificate requirements
3. grading policies
4. educational program development
5. standards or policies regarding student preparation and success
6. district and college governance structures, as related to faculty roles
7. faculty roles and involvements in accreditation processes, including self-study and annual reports
8. policies for faculty professional development activities
9. processes for program review
10. processes for institutional planning and budget development
- +1. other academic and professional matters as mutually agreed upon between the Board of Trustees and the Academic Senate.

#### NAS PURPOSE:

The purposes of the Academic Senate shall be (1) to participate in the formation of policies and procedures in academic and professional matters; (2) to coordinate communication from the Riverside Community College District Academic Senate and the Academic Senates of the Moreno Valley, and Riverside City Colleges; and (3) to facilitate communication between the administration, faculty, students, and the Board of Trustees in all matters relating to community college education.

### SUMMARY OF SENATE ACTIVITY Fall 2018:

#### *Information items:*

The senate received presentations updating senators, alternates and attendees on an array of important issues.

- Reviewed the roles and responsibilities of the academic senate.
- Were presented an update BP/AP 4230 to include Excused Withdrawal (EW) grade.
- Were informed of the intention to support 2-4 faculty interns each year (pending funding), based on BP/AP 7200. Jason Parks and Dominique Hitchcock will initiate the program.
- Received information regarding the new LRC online tutor appointment and student tracking system, of its functions, how students register, and plans for measuring student success in collaboration with faculty.
- Were given a demonstration of the Military Articulation Platform that will provide veterans educational credit for prior learning experience.
- Reviewed the new Norco College and Norco Academic Website.
- APC forwarded new faculty hire prioritization list with a recommendation that the Norco College administration attempt to find a way to hire the top five. The way faculty prioritization occurs will be revisited in the spring.
- Received an overview of Norco College's 2018-19 and 2019-2020 Promise Program implementation plans to comply with AB19.

- Were provided an update regarding the Phoenix Scholars Center and available resources for current and former foster youth.
- Were provided an update on where we are at and what is in the future regarding dual enrollment.
- DRC informed the senate of its need for testing space and requested senate assistance.

*Discussion items:*

- As of fall 2019 all curriculum submissions must include objectives; therefore the senators discussed the differences between SLOs and Objectives to share with their department faculty.
- The District Academic Affairs office has asked us to review and update the Discipline Facilitator List. The functions of the discipline facilitators was discussed and will be brought back to the Vice-Chancellor of Academic Affairs.
- The Norco College Leading from the Middle team presented the Professional Development plan for discussion.
- President Reece is seeking the creation of a President's Honor List distinguishing Norco College students with outstanding GPA's.
- Academic Senate and Senate Standing Committee Evaluation of Effectiveness Survey Results for 2017-2018 were discussed via email for suggested improvements.

*Action items:*

- In addition to the faculty members identified by senate subcommittee chairs as voting members in their reports to the senate, the following faculty members were approved as committee or council voting members:
  - Andy Robles on the Marketing Committee
  - Dominique Hitchcock on the faculty internship program
  - Courtney Buchanan on BFPC
  - Peggy Campo will replace Phu Tran temporarily on BFPC and faculty co-chair for Standard IIIB/D Accreditation Sub-committee until his return
- BP/AP3950, was updated by District legal to Naming of Facilities, Events, and Programs. This updated BP/AP was voted down by the Norco Academic Senate, but passed at the District since it was approved by both the RCCAS and MVAS.
- We approved NAS Resolution 2018-01, Support for the Library's Role in Success and Completion.

**STRATEGIC GOALS AND OBJECTIVES THAT APPLY TO THIS COMMITTEE:**

Twenty-nine of the forty-one objectives under our 7 strategic goals are either a direct responsibility of the NAS or of one of its subcommittees. This report will only mention goals and objectives that were addressed this semester and reported out by committee chairs.

**Goal 5: Strengthen Student Learning**

**Objective 2: (together with SSPC) Increase the percentage of student learning and service area outcomes assessments that utilize authentic methods.**

- Ongoing trainings on the use of Nuventive and methods of assessment
- Feedback on Annual Program Review and the Key Indicator Analysis
- Re-sharing of documents regarding ways to assess at the SLO and ProLO level
- Creating a "best practices" document regarding SLO and ProLO assessment
- Created and maintained a set of documents to record SLOs that have never been assessed or have not been assessed in the current cycle.
- Communicated with administration, academic senate, and faculty association representatives to develop a plan to ensure all SLOs, all courses
- Created an online survey to allow faculty to report SLO data without having to interact with Nuventive.

Objective 3: (together with SSPC) Increase the percentage of programs that conduct program level outcomes assessment that closes the loop.

- Create awareness of the need to ensure that all ProLOs in all Programs need to be assessed in preparation for the 2020 accreditation visit.
- Revised the college cycle of assessment matrix to link onto the new 6-year assessment cycle.
- Collected data for the AOE in CML and the GELO #4: Self-development and Global Awareness.

Objective 4: (together with DE) Increase assessment of student learning in online courses to ensure that it is consistent with student learning in face-to-face courses.

- Collaborated with Program Review and Distance Education to embed SLOs in all Canvas shells.

Goal 7: Strengthen Our Commitment to our Employees

Objective 4: (together with the Diversity, Equity, & Inclusion Committee) Increase participation in events and celebrations related to inclusiveness.

Flyers are distributed both in person and via mailboxes. Announcements are also made at meetings to spread the word about these important library events.

In addition, copies of our Read 2 Succeed book are distributed to faculty, staff and students so they can more fully participate in the activities of the college-wide read.

The fall 2018 Read 2 Succeed book was [Lives in Limbo: Undocumented and Coming of Age in America](#) by Roberto G. Gonzales and was in partnership with our Rise Club (formerly Dreamers Club). The author spoke on campus November 15, 2018. Below are the author's comments after his visit to Norco College.

“Thank you, Norco College, for choosing my book, *Lives in Limbo*, as its Read 2 Succeed book for the semester. It was an honor for me to present my work to students, faculty, and staff. And I was heartened by the response to my visit—everyone was welcoming and hospitable. Given its demographic profile, I knew that the Norco/Corona region is no stranger to questions of immigration. Throughout my campus visit, I found the community at Norco College to be deeply engaged, insightful and forward thinking in its response to both my book and my presentation. I was particularly impressed by Norco's

students, and I appreciated the opportunity to talk with so many of them. While some had direct connections to the subject material of my book, others mentioned to me that this was an issue about which they had little prior knowledge. But many expressed a desire to do something. One student in particular told me, "This is important. We've got to fix this problem." I sincerely hope that my book has sparked an interest that will motivate further inquiry and action. The students of Norco College represent the future of California and of this nation. I left Norco feeling more optimistic than I was when I arrived. With the committed and caring faculty at Norco, I sincerely believe the students will be centrally involved in crafting solutions to these complex problems. --**Roberto G.
