**F. Discussion / Information items:**

**1. META Information:** The old CurricUNET is to have public access in META. The objective header is showing with an empty field and a request has been made for them (the IT programmers) to fix it. The login is your @rcc.edu email address and the default password is: ChangeMe1

Faculty are encouraged to review and become familiar with the new META website. They can access it by clicking on the old link, which will automatically reroute the user to the correct webpage. The Distance Education proposals are different on META. To look up DE proposals approved, currently, there is no way to tell which COR is a DE. It was suggested that we ask the programmers for META to put an identifier (DE) on the website list so we can locate the correct course title.

**2. POR Modification:** The hope is that it can be completed by META in the spring of 2017. The senate stated that not having the word "Course Objective" is OK by the state. We don't want an empty field in the COR. It appears to be showing only in the new courses being created. The issue is that some COR has outcomes listed and some have both objectives and outcomes listed. The issue is the CID problems and getting courses approve. We need consistency. The discussion is that we should have two (Outcomes and Objectives). It is up to the academic senate to make the final decision.

**G. Announcements:**

1. Rex Beck informed the committee that Nick Franco was asked to work towards transfers agreement for the business disciplines with both Brandon University and Western Governors University. Mr. Franco worked very hard on the negotiations until completion and the business department is very grateful for his efforts. Great job Nick! ☺

2. Moreno Valley Curriculum chair, that MVC is looking into adopting four new certificates that are similar to our courses. There is a possible conflict of interest. Graphic communication (CE 823), Graphic design (CE 822), Computer application (CE 637) and Computer CE (CE 633). The issue is that Norco College has Graphic Design program. The issue is that Norco College was denied a certificate (Medical Secretary) that was similar to one at MVC (Medical Assistance); therefore, does Norco College have any recourse to contest this? What is the process of protocol for a college to adopt a program of study that is offered at another college that might be in conflict or competition?
